- Section 2. The revised class specification for ASSOCIATE PLANNER - EMERGENCY SERVICES, Salary Range 152, (\$6,132 - \$7,824) assigned to the CARSON PROFESSIONALS AND SUPERVISORS ASSOCIATION is hereby adopted.

Sextion 3. Reclassfy the Associate Planner in the Planning Department to the newly created classification mentioned in this resolution.
