

RESOLUTION NO. 19-001

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CARSON, CALIFORNIA, RECITING THE FACT OF THE GENERAL MUNICIPAL ELECTION HELD ON NOVEMBER 6, 2018, DECLARING THE RESULT OF THE CITY COUNCIL, CITY CLERK, CITY TREASURER AND SUCH OTHER MATTERS AS PROVIDED BY LAW

WHEREAS, a General Municipal Election was held and conducted in the City of Carson, California, on Tuesday, November 6, 2018, as required by law; and

WHEREAS, the City Clerk served as the local Election Official for the City Council contest and Ballot Measure CA (City Charter); and

WHEREAS, the Senior Deputy City Clerk served as the local Election Official for the City Clerk and City Treasurer contests; and

WHEREAS, notice of the election was given in time, form and manner as provided by law; that voting precincts were properly established; that election officers were appointed and that in all respects the election was held and conducted; the votes were cast, received and canvassed and the returns made and declared in time, form and manner as required by the provisions of the Elections Code of the State of California for the conduct of elections in general law cities; and

WHEREAS, the Los Angeles County Registrar-Recorder/County Clerk canvassed the returns of the election and has certified the results to this City Council, the results are received, attached and made a part of hereof as "Exhibit A".

NOW, THEREFORE, THE CITY COUNCIL OF CARSON DOES HEREBY RESOLVE, FIND, DETERMINE, AND ORDER AS FOLLOWS:

Section 1. That the whole number of ballots cast in the precincts except vote by mail voter ballots was 19,102. The whole number of vote-by-mail voter ballots cast in the City was 11,728, making a total of 30,830 ballots cast in the City of Carson.

Section 2. That the names of persons voted for at the election for Member of the City Council are as follows:

Section 3. That the number of votes given at each precinct and the number of votes given in the City to each of the persons above named for the respective offices for which the persons were candidates were as listed in Exhibit "B" attached.

Section 4. The City Council does declare and determine that:

LULA DAVIS-HOLMES was elected as member of the City Council for a four-year term;

JIM DEAR was elected as member of the City Council for a four-year term;

DONESIA GAUSE-ALDANA was elected as the City Clerk for a four-year term;

MONICA COOPER was elected as City Treasurer for a four-year term.

Section 5. The City Clerk shall enter on the records of the City Council of the City, a statement of the result of the election, showing (1) the whole number of ballots cast in the City; (2) the names of the persons voted for; (3) for what office each person was voted for; (4) the number of votes given at each precinct to each person; and (5) the total number of votes given to each person.

Section 6. That the City Clerk or Senior Deputy City Clerk shall immediately make and deliver to each of the persons so elected a Certificate of Election signed by the City Clerk or Senior Deputy City Clerk and authenticated; that the City Clerk or Senior Deputy City Clerk shall also administer to each person elected the Oath of Office prescribed in the Constitution of the State of California and shall have them subscribe to it and file it in the office of the City Clerk.

Section 7. That the City Clerk shall certify to the passage and adoption of this resolution and enter it into the book of original resolutions.
