## **RESOLUTION 19-015**

- A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CARSON, CALIFORNIA, AMENDING AND RATIFYING RESOLUTION NO. 18-170 ESTABLISHING THE SALARY AND BENEFITS FOR UNCLASSIFIED MANAGEMENT EMPLOYEES EFFECTIVE DECEMBER 4, 2018
- **WHEREAS**, the City Council adopted Resolution No. 16-095 on August 2, 2016, establishing the salary and benefits for Unclassified Management Employees; and
- **WHEREAS**, the City Council adopted Resolution No. 18-170 on December 4, 2016, restating and replacing any and all pre-existing salary and benefit resolutions for the Unclassified Management Employees, including, but not limited to, Resolution No. 16-095 and included attachments; and
- **WHEREAS**, Section 4.1 of Resolution No. 18-170 inadvertently omitted three (3) floating holidays for unclassified management employees; and
- **WHEREAS**, Attachment B to Resolution No. 16-095, which sets forth the monthly salary schedule for the City Manager for purposes of determining acting pay, was inadvertently omitted from Resolution No. 18-170; and
- **WHEREAS**, the City Council now desires to amend and ratify Resolution No. 18-170 establishing the salary and benefits for Unclassified Management Employees and include all intended attachments.
- NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF CARSON, CALIFORNIA, DOES HEREBY RESOLVE AS FOLLOWS:
- **SECTION 1.** The above recitals are true and correct and incorporated herein by this reference.
- **SECTION 2.** The City Council amends Resolution No. 18-170 to add Attachment B (identical to Attachment B to Resolution No. 16-095), ) and include the three (3) floating holidays to be provided to unrepresented management employees, and ratifies the City Council action in adopting Resolution No. 18-170. The addition of Attachment B to Resolution No. 18-170 and provision of three (3) floating holidays shall shall be deemed effective retroactive to December 4, 2018.
  - **SECTION 3**. This Resolution shall be effective immediately upon passage and adoption.
- **SECTION 4.** The City Clerk shall certify to the passage and adoption of this Resolution and enter it into the book of original Resolutions.
