Section 2. The revised job classification specifications for PUBLIC WORKS RIGHT-OF-WAY AND MAINTENANCE SUPERINTENDENT AND LANDSCAPE AND BUILDING MAINTENANCE SUPERINTENDENT assigned to the Association of Management Employees (AME), are hereby adopted.
