

ORDINANCE NO. 18-1827

AN ORDINANCE OF THE CITY OF CARSON, CALIFORNIA, AMENDING THE MUNICIPAL CODE TO ADD THE NAMES AND LOCATIONS OF ALL THE CITY'S PARKS

WHEREAS, Chapter 7(D) details various aspects of the Department of Parks and Recreation, such as the duties of its Director and its Divisions; and

WHEREAS, there is now a request to add the names and locations of all the City's parks to the Municipal Code.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF CARSON, CALIFORNIA DOES HEREBY ORDAIN AS FOLLOWS:

Section 1. Section 2734 of the Carson Municipal Code, relating to the names and locations of all the City's parks, shall be added to read in its entirety as follows:

"Section 2734. Parks in the Department of Parks and Recreation

The Department of Parks and Recreation is responsible for the operations and maintenance of a total of sixteen (16) parks. Of this total, twelve (12) are full-service parks and four (4) are mini parks.

A. The names and locations of the twelve (12) full-service parks are as follows:

- i. Anderson Park – 19101 South Wilmington Avenue, Carson, California 90746
- ii. Calas Park – 1000 East 2201th Street, Carson, California 90745
- iii. Carriage Crest Park – 23800 South Figueroa Street, Carson, California 90745
- iv. Carson Park – 21411 South Orrick Avenue, Carson, California 90745
- v. Del Amo Park – 703 East Del Amo Boulevard, Carson, California 90745
- vi. Dolphin Park – 21205 Water Street, Carson, California 90745
- vii. Dominguez Park – 21330 Santa Fe Avenue, Carson, California 90810
- viii. Foisia Park – 23410 Catskill Avenue, Carson, California 90745
- ix. Hemingway Park – 700 East Gardena Avenue, Carson, California 90746
- x. Mills Park – 1340 East Dimondale Drive, Carson, California 90746
- xi. Stevenson Park – 17400 Lysander Drive, Carson, California 90746
- xii. Veterans Park – 22400 Moneta Avenue, Carson, California 90745

B. The names and locations of the four (4) mini parks are as follows:

- i. Friendship Mini Park – 21930 South Water Street, Carson, California 90745
- ii. Perry Street Mini Park – 215th and Perry Street, Carson, California 90745
- iii. Reflection Mini Park – 21208 Shearer Avenue, Carson, California 90746
- iv. Walnut Mini Park – 440 East Walnut Avenue, Carson, California 90746”

Section 2. If any provision(s) of this ordinance of the application therefor to any person or circumstance is held invalid or unconstitutional by any court of competent jurisdiction, such validity or unconstitutionality shall not affect any other provision or application, and to this end the provisions of this ordinance are declared unseverable. The City Council hereby declares that they would have adopted this ordinance and each section, subsection, sentence, clause, phrase, part or portion therefore, irrespective of the fact that any one or more sections, subsections, clauses, phrases, parts or portions thereof shall be declared invalid or unconstitutional.

Section 3. The City Clerk shall certify to the adoption of this Ordinance, and shall cause the same to be posted and published in the manner required by law.

Section 4. This ordinance shall be effective thirty (30) days following its adoption.
