

Exhibit 1: Cities that allow signs in the Public Right-of-Way

<u>City</u>	<u>No. of Signs allowed in PROW</u>	<u>Restrictions on Signs in PROW</u>
<u>Newport Beach</u>	3	<ul style="list-style-type: none"> • Not in medians or anywhere within the traveled way of any street or highway, • Not installed in a manner that creates a hazard to traffic or pedestrians. • The sign shall not be attached to any public property.
<u>Rancho Palos Verdes</u>	No total restriction. Limited to maximum of 3 lead-in signs at any intersections	<ul style="list-style-type: none"> • 1 pm – 6 pm on Saturdays & Sundays • Only one lead-in sign may be placed per traffic direction at an intersection. • Not within traffic median • No larger than three square feet and are to be the color combination of brown and gold
<u>Grand Terrace</u>	Maximum of 25 signs per licensed entity may be temporarily placed in the public right-of-way at any one time.	<ul style="list-style-type: none"> • Only be placed in landscaped parkways, and shall not be placed on the sidewalk or in the center street median. • Thursday through Sunday during the hours of 8:00 a.m. to 5:00 p.m.
<u>Yuba City</u>	Max. of 3	<ul style="list-style-type: none"> • The sign or signs may not be placed more than 12 hours before the start or remain more than 12 hours after the conclusion of the open house event.
<u>Hesperia</u>	Up to 3 signs	<ul style="list-style-type: none"> • Daylight hours on the day of the open house • Located at least thirty (30) feet from an intersection and fifteen (15) feet from the edge of the pavement. • Only owners, salespersons or licensed real estate brokers holding a current city business license may place off-site open house signs. • Allowed overnight for multiple day event, however must be removed before dusk on the final day.

Whittier	7 Open House & 4 Yard Sale signs	<ul style="list-style-type: none"> • A distance of five hundred feet or more is required between individual temporary directional signs on the same street, • This limitation does not apply to signs that pertain to different properties.
Walnut Creek	4 off site signs	<ul style="list-style-type: none"> • Not in medians or blocking sidewalks. • Weekends, holidays, broker tour days, between 10 and 5, • To be removed at end of each day.
Cerritos	Unspecified	<ul style="list-style-type: none"> • Shall not be placed in medians or other areas located between traffic lanes • Signs shall not be placed on sidewalks, walkways or other areas designated for pedestrian circulation • Garage sale signs shall be allowed only on Saturdays and Sundays between the hours of nine a.m. and six p.m. • Real estate open house directional signs shall be allowed only on Wednesdays between the hours of nine-thirty a.m. and one-thirty p.m. and on Saturdays and Sundays between the hours of nine a.m. and six p.m. • On arterial streets, only two real estate open house directional signs for the same open house and only two garage sale signs for the same garage sale shall be permitted between street intersections on the same side of the street; and • In the interior of residential tracts, only one real estate open house directional sign for the same open house shall be permitted for each directional change
Cypress	Unspecified	<ul style="list-style-type: none"> • Approval from the director of public works required.
