Devon Tsuno and Aandrea Stang, California State University Dominguez Hills Professors – Item No. 24

Spoke in Support of Item No. 24. Thanked the Council for considering their cultural arts proposal for City parks. They noted several CSUDH undergraduates and professors are volunteering to work this free program.

Paul Sims, Centerview Track Home Resident

Stated oversized trucks disturb resident's homes when they hit potholes while traveling through the area. He mentioned a parking issue near his home. He is requesting to implement permitted parking. He noted in the center median on Walnut, there is mulch that has not been landscaped.

Mayor Robles referred him to Public Works Director, Williams-Slaughter about his permit parking request and pothole issues.

Council Member Davis-Holmes noted that several complaints have been made about truck traffic.

Alexey Steele, Carson Resident - Item No. 24

Ana Meni, AFSCME President Local #809 - Item No. 21

Spoke in opposition of Item No. 21. Concerned about not having a companion staff report outlining the organizational chart for subordinate staff. She mentioned the submitted organizational chart was incorrect. In addition to the organizational chart should never include employee's names to avoid favoritism or retaliation issues. She also inquired about the salary range.

Council Member Davis-Holmes noted she requested an organizational chart and wanted to know employee's names, titles and locations.

Blues Man Reed, Rockin Blues Entertainment CEO - Item No. 24

Spoke in support of Item No. 24. In addition, spoke about the importance of his entertainment company to the special needs community. He requested City Council consider funding the program.

Mila Boyer, Carson Resident - Item No. 30

Williams Koons, Carson Resident - Item No. 16 and No. 19
