AMENDMENT NO. 2

TO AGREEMENT FOR CONTRACTUAL SERVICES

THIS AMENDMENT TO THE AGREEMENT FOR CONTRACTUAL SERVICES ("Amendment No. 2") by and between the CITY OF CARSON ("City") and CSG Consultants, Inc., a California corporation ("Consultant") is effective as of the ____ day of March, 2019.

RECITALS

- A. City and Consultant entered into that certain Agreement for Contractual Services dated December 6, 2016 ("Agreement") whereby Consultant agreed to provide On-Call Planning Services.
- B. Since the Agreement was initiated, the City has experienced an increased demand for on-call planning services from projects such as the District at South Bay Specific Plan Amendment and Supplemental Environmental Impact Report.
- C. In order to meet this increased demand for on-call planning services, City and Consultant entered into Amendment No. 1 to the Agreement on November 6, 2017, whereby City and Consultant increased the Contract Sum from \$300,000 to \$600,000.
- D. Since November 6, 2017, the City has continued to experience an increased demand for on-call planning services and has recently lost a number of full-time staff planners due to retirement, promotion and resignation. In order to continue to meet this increased demand for planning services, continue review of development projects in a timely manner and maintain a high level of service, the City must further increase the Contract Sum of the Agreement.
- E. City and Consultant now desire to amend the Agreement to increase the Contract Sum by \$221,000 for a not to exceed amount of \$821,000 to enable the Consultant and City to continue to meet the increased demand for planning services.

TERMS

- 1. **Contract Changes**. The Agreement is amended as provided herein (new text is identified in *bold italics*, deleted text in strike through).
 - a. Section 2.1, "Contract Sum," is hereby amended as follows:

"Subject to any limitations set forth in this Agreement, City agrees to pay Consultant the amounts specified in the "Schedule of Compensation" attached hereto as Exhibit "C" and incorporated herein by this reference. The total compensation, including reimbursement for actual expenses, shall not exceed *Eight Hundred Twenty One Thousand Dollars (\$821,000.00)* Six Hundred Thousand Dollars (\$600,000.00) for the entire Term, and shall not exceed Two Hundred Thousand Dollars (\$200,000.00) annually (the "Contract Sum"), unless additional compensation is approved pursuant to Section 1.8."

b. Section IV. of Exhibit C, "Schedule of Compensation," is hereby amended as follows:

"The total compensation for the Services shall not exceed \$821,000\\$100,000 annually, and will not exceed \$300,000 in total, as provided in Section 2.1 of this Agreement."

- 2. **Continuing Effect of Agreement.** Except as amended by this Agreement, all provisions of the Agreement shall remain unchanged and in full force and effect. From and after the date of this Amendment No. 2, whenever the term "Agreement" appears in the Agreement, it shall mean the Agreement, as amended by this Amendment No. 2 to the Agreement.
- 3. Affirmation of Agreement; Warranty Re Absence of Defaults. City and Consultant each ratify and reaffirm each and every one of the respective rights and obligations arising under the Agreement. Each party represents and warrants to the other that there have been no written or oral modifications to the Agreement other than as provided herein. Each party represents and warrants to the other that the Agreement is currently an effective, valid, and binding obligation.

Consultant represents and warrants to City that, as of the date of this Amendment No. 2, City is not in default of any material term of the Agreement and that there have been no events that, with the passing of time or the giving of notice, or both, would constitute a material default under the Agreement.

City represents and warrants to Consultant that, as of the date of this Amendment No. 2, Consultant is not in default of any material term of the Agreement and that there have been no events that, with the passing of time or the giving of notice, or both, would constitute a material default under the Agreement.

- 4. **Adequate Consideration.** The parties hereto irrevocably stipulate and agree that they have each received adequate and independent consideration for the performance of the obligations they have undertaken pursuant to this Amendment No. 2.
- 5. **Authority.** The persons executing this Agreement on behalf of the parties hereto warrant that (i) such party is duly organized and existing, (ii) they are duly authorized to execute and deliver this Agreement on behalf of said party, (iii) by so executing this Agreement, such party is formally bound to the provisions of this Agreement, and (iv) the entering into this Agreement does not violate any provision of any other Agreement to which said party is bound.
