RESOLUTION NO. 19-111

A RESOLUTION OF THE CARSON CITY COUNCIL AMENDING THE FISCAL YEAR 2018-19 BUDGET TO ACCEPT THE LA84 FOUNDATION GRANT THAT WILL SUPPORT THE SUMMER SPLASH PROGRAM

WHEREAS, the City Council adopted the City's Fiscal Year (FY) 2018-19 budget on June 19, 2018; and

WHEREAS, the LA84 Foundation is a nationally recognized leader in support of youth sport programs and public education about the role of sports in positive youth development. The foundation, with 30 years of on-the-ground experience, has supported thousands of Southern California youth sports organizations through grant making, while also training coaches, commissioning research, convening conferences and acting as a national thought leader on important youth sports issues; and

WHEREAS, the City of Carson was recently awarded a \$10,000.00 grant – approximately \$9,500.00 in funds and approximately \$500.00 in t-shirts - from the LA84 Foundation to support the Summer Splash Program; and

WHEREAS, the funds will be used to provide partial scholarships to youth who wish to participate in swimming lessons, swim team (water polo) and artistic swim (synchronized swimming). Specifically, the money will defray half the cost of youth participating in 2-3, 2-week sessions of swimming lessons, water polo or synchronized swimming; and

WHEREAS, approximately 120 youth will benefit from this grant; and

WHEREAS, the City Council desires to amend FY 2018-19 budget in order to accept these funds.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF CARSON DOES HEREBY RESOLVE, FIND, DETERMINE, AND ORDER AS FOLLOWS:
