

RESOLUTION NO. 18-014

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CARSON, CALIFORNIA, AUTHORIZING THE SUBMITTAL OF A MOBILE SOURCE AIR POLLUTION REDUCTION REVIEW COMMITTEE (MSRC) GRANT APPLICATION

WHEREAS, the Mobile Source Air Pollution Reduction Review Committee (MSRC) has established a Local Government Partnership Program to provide local jurisdictions with a funding opportunity to improve air quality; and

WHEREAS, in furtherance of this authority MSRC is required to establish procedures governing the administration of the Local Government Partnership Program; and

WHEREAS, MSRC's procedures for administering the Local Government Partnership Program require, among other things, an applicant's governing body to declare by resolution certain authorizations and acknowledgements related to the administration of the Local Government Partnership Program.


NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF CARSON DOES HEREBY RESOLVE AS FOLLOWS:


- Section 1.** Authorizes the submittal of a MSRC grant application
- Section 2.** Acknowledges receipt of the MSRC – supplied presentation from City Staff
- Section 3.** Authorizes the proposed project to receive MSRC funding related to the purchase and/or support of zero and near-zero emission vehicles
- Section 4.** Allocates the necessary matching funds for the proposed project
- Section 5.** Based on the aforementioned findings, the City Council hereby approves Resolution No. 18-014
- Section 6.** The City Clerk shall certify to the adoption of this Resolution and shall transmit copies of the same to the applicant


