AMENDMENT NO. 25

TO AGREEMENT FOR CONTRACTUAL SERVICES

THIS AMENDMENT TO THE AGREEMENT FOR CONTRACTUAL SERVICES ("Amendment") by and between the CITY OF CARSON, a California municipal corporation ("City") with <u>SUPERION</u>, <u>LLC</u>, a <u>Delaware corporation</u>, successors to <u>SUNGARD PUBLIC</u> <u>SECTOR INC</u>., (collectively "Contractor") is effective as of the <u>1st</u> day of <u>August</u>, <u>2018</u>.

RECITALS

- A. City and Contractor entered into that certain Agreement for Contractual Services dated September 30, 1993 (" Agreement") with a contract period of one year, whereby Contractor agreed to install and provide financial management and accounting software Services.
- B. Agreement provides City the option of annual renewal of provision by Contractor of the financial management and accounting software Services.
- C. Subsequent to the original one year period of coverage, the Agreement has been renewed regularly on an annual basis to continue the provision of financial management and accounting software Services by Contractor to City.
- D. City and Contractor now desire to amend the Agreement for the 25th time, constituting the 25th extension of annual coverage, by memorializing in writing a renewal for the period of August 1, 2018 through July 31, 2019 of Contractor's maintenance coverage pursuant to Section 11 [" Extended Maintenance"] of the Agreement.

TERMS

- 1. **Contract Changes**. The Agreement is amended as provided herein.
- a. Section 11 of this Agreement remains as written and previously amended, with the exception of the following language is to be added to the end of Section 11 (" Extended Maintenance"):

City elects to renew BI- TECH's maintenance and support coverage, as provided herein, for the period of August 1, 2018 through July 31, 2019, for the amount of \$59,490.67.

- 2. **Continuing Effect of Agreement.** Except as amended by this Agreement, all provisions of the Agreement shall remain unchanged and in full force and effect. From and after the date of this Amendment, whenever the term "Agreement" appears in the Agreement, it shall mean the Agreement, as amended by this Amendment to the Agreement.
- 3. **Affirmation of Agreement; Warranty Re Absence of Defaults.** City and Contractor each ratify and reaffirm each and every one of the respective rights and obligations arising under the Agreement. Each party represents and warrants to the other that there have been no written or oral modifications to the Agreement other than as provided herein. Each party

represents and warrants to the other that the Agreement is currently an effective, valid, and binding obligation.

Contractor represents and warrants to City that, as of the date of this Amendment, City is not in default of any material term of the Agreement and that there have been no events that, with the passing of time or the giving of notice, or both, would constitute a material default under the Agreement.

City represents and warrants to Contractor that, as of the date of this Amendment, Contractor is not in default of any material term of the Agreement and that there have been no events that, with the passing of time or the giving of notice, or both, would constitute a material default under the Agreement.

- 4. **Adequate Consideration.** The parties hereto irrevocably stipulate and agree that they have each received adequate and independent consideration for the performance of the obligations they have undertaken pursuant to this Amendment.
- 5. **Authority.** The persons executing this Agreement on behalf of the parties hereto warrant that (i) such party is duly organized and existing, (ii) they are duly authorized to execute and deliver this Agreement on behalf of said party, (iii) by so executing this Agreement, such party is formally bound to the provisions of this Agreement, and (iv) the entering into this Agreement does not violate any provision of any other Agreement to which said party is bound.
