#### I. SUMMARY

Since 1968, the County of Los Angeles Department of Animal Care and Control has provided the City of Carson with animal control services. The most recent agreement was approved by City Council at the May 1, 2007 meeting (Exhibit No. 1). That agreement expired on June 30, 2014. Staff recommends that a new five-year agreement with the County of Los Angeles Animal Care and Control be approved for the period of July 1, 2014 through June 30, 2019 (Exhibit No. 2).

#### II. <u>RECOMMENDATION</u>

TAKE the following actions:

- 1. APPROVE the five-year agreement with County of Los Angeles Department of Animal Care and Control to provide animal control services for the City of Carson, for the period of July 1, 2014 through June 30, 2019.
- 2. AUTHORIZE the Mayor to execute the agreement, following approval as to form by the City Attorney.

### III. <u>ALTERNATIVES</u>

TAKE such other action as the City Council deems appropriate that is consistent with the requirements of law.

### IV. <u>BACKGROUND</u>

The County of Los Angeles Department of Animal Care and Control has provided the City of Carson with animal control services since 1968. These services include providing kennel and animal shelter services, shelter and treatment of all animals, reptiles and fowl delivered to the shelter from within the boundaries of the City, impounding stray dogs and cats, disposal of dead animals and enforcement of state statutes and municipal animal control ordinances.

The rates for these services for FY 2013/2014 are as follows:

Animial Control Officer Field patrol	\$85.02 per hour

The cost for the services is offset by impound fees and housing fees, along with license fees collected at the shelter that are credited to the City monthly. For example, the cost for providing animal control services to the City of Carson in FY 2012/13 was \$342,623.64. The City received credits that totaled \$167,525.40 for the same year. The net cost to the City was \$175,098.24. However, it is anticipated that the total cost of the services for FY 2013/2014 will end up being \$222,000. Attached is the invoice from Los Angeles Department of Animal Care and Control for May 2014 that shows the typical breakdown of costs and credits to the city for FY 2013/2014. (Exhibit No. 3).

These rates are adjusted by the County Auditor-Controller annually, and effective July 1<sup>st</sup> of each year for the animial care and control services. (Exhibit No. 2). The County of Los Angeles Department of Animal Care and Control has provided excellent service to the City of Carson. Based on their service, responsiveness, and overall performance, staff recommends that a new contract with County of Los Angeles Animal Care and Control be approved. This contract will be a five-year agreement, commencing on July 1, 2014 and ending on June 30, 2019.

### V. FISCAL IMPACT

Funds for animal control services are included in the proposed FY 2014/15 budget in account number 01-90-905-158-6005. Funds to reflect the future annual contract costs will also be included in succeeding annual budgets.
