# Report to Mayor and City Council

#### SUBJECT:

CONSIDER EXTENDING A FEE WAIVER FOR THE USE OF THE CONGRESSWOMAN JUANITA MILLENDER-MCDONALD COMMUNITY CENTER AT CARSON FOR APOLLO WEST CARSON PLAYERS, ASOCIACION CULTURAL DE SOUTH BAY OF GREATER LOS ANGELES MARIACHI ACADEMY AND SOPHISTICATED DANCE

#### I. <u>SUMMARY</u>

This item is on the agenda at the request of Councilwoman Lula Davis-Holmes.

On July 2, 2013 the City Council voted to waive fees for the use of the Congresswoman Juanita Millender-McDonald Community Center at Carson (Community Center) for three community groups that previously received funding by the City Council through the City's Cultural Arts commission (Exhibit No.1). The fee waiver was provided in order to assist these groups with holding rehearsals and meetings, and their fundraising efforts. The term of the fee waiver was for Fiscal Years 2013-2014 and 2014-2015, a 2-year fee waiver. Tonight, the City Council is asked to provide direction to staff regarding whether to continue waiving the fees for the use of the Community Center for the three groups, Apollo West Carson Players (Carson Players), Asociacion Cultural de South Bay of Greater Los Angeles Mariachi Academy (Mariachi Academy of Carson) and Sophisticated Dance.

### II. RECOMMENDATION

 APPROVE a fee waiver extension for additional 2-years for Apollo West Carson Players (Carson Players), Asociacion Cultural de South Bay of Greater Los Angeles Mariachi Academy (Mariachi Academy of Carson) and Sophisticated Dance.

### IV. BACKGROUND

The City of Carson has provided funding for fine arts programming through the Cultural Arts Commission since the 1980s. With the City's budget challenges, this program was suspended until a time when it would be financially feasible for the City to restart the program. In the interim, the City Council voted to waive fees for use of the Community Center for the Carson Players and Mariachi Academy of Carson, City of Carson Cultural Arts Commission Contractors. While Sophisticated Dance was not previously a contractor with the City of Carson through the Cultural Arts Commission, they were included in the waiver because they submitted an application to be considered for a contract during the period of the City's budget challenges. Action was taken in order to assist them with their fundraising activities as well as to hold meetings and rehearsals. Subsequently, Sophisticated Dance did receive Cultural Arts Commission contract funding.

Tonight, the City Council is asked to provide direction to staff regarding whether to extend the fee waiver.

#### V. FISCAL IMPACT

Should the fee waiver be extended, the estimated total revenue loss is **\$46,850.00** per year. If rates increase in the future, the estimated loss would also increase.
