Districting Ordinance Adoption

- **May 21, 2019.** First Public Hearing prior to publication of drafts maps.
- **June 13, 2019.** Second Public Hearing prior to publication of drafts maps.
- **June 18, 2019.** Third Public Hearing prior to publication of drafts maps.
- **July 30, 2019.** Draft Maps Published on City's Web Site for public review.
- **August 6, 2019.** First Public Hearing after publication of drafts maps.
- **August 17, 2019.** Second Public Hearing after publication of draft maps.

Districting Ordinance Adoption

- **September 17, 2019.** Public Hearing on Maps and Election Sequencing.
- **September 24, 2019.** Publish Additional Maps with Election Sequencing for Review.
- **October 1, 2019.** Second Public Hearing on Election Sequencing.
- **October 1, 2019.** Introduce for First Reading Districting Ordinance. (Separate Public Hearing).
- **October 15, 2019.** Adoption of Districting Ordinance (Second Reading).
- **November 15, 2019.** Ordinance Effective Date.
