City Manager Landers announced the City received the following awards from the California Parks and Recreation Society: 1) City of Carson Intergenerational Program Bridging the Gap Between Generations and 2) Alexey Steele's, Love My Neighbor Public Art Project, in the Scottsdale neighborhood. She announced a banquet to be held on March 13, 2020 and will provide more information at a later time.

# ORAL COMMUNICATIONS FOR MATTERS NOT LISTED ON THE AGENDA (MEMBERS OF THE PUBLIC) (LIMITED TO ONE HOUR)

(Mayor Pro Tem/Agency Vice Chairman/Authority Vice Chairman Dear reentered the meeting.)

<u>Drexel Johnson, Executive Director/Founder, Black Contractors Association, Vice President of the Nationals, and President of the Los Angeles Chapter</u>

Spoke about issues with several Transportation Trucking contractors. He referred to Dragados who is not treating workers fairly in the workforce and would like a fair opportunity. In addition, he announced Black History Month.

Council Member/Agency Member/Authority Board Member Davis-Holmes noted that Mr. Johnson had attended several Council meetings. She would like City be proactive with implementing the City of Inglewood's workforce plan.

Mayor Pro Tem/Agency Vice Chairman/Authority Vice Chairman Dear noted he has seen a lack of diversity in the contractor workforce and recommends staff work with the City Attorney for a resolution.

Council Member/Agency Member/Authority Board Member Hilton echoed Mr. Johnson's sentiments and the importance of local hire. He directed the City Manager to identify a Compliance Officer who will provide a Compliance Report where the workforce benefits Carson residents.

Council Member/Agency Member/Authority Board Member Hicks stated he supports his colleague's recommendations and for City Attorney to ensure Carson residents are included.

City/Agency/Authority Attorney Soltani noted the citywide Project Labor Agreement and City Charter addresses the issue of diversity in construction workforce. The next step is for the City to move forward on a Compliance Officer Request for Proposal ensuring the developers comply with current Charter language.

Mayor Pro Tem/Agency Vice Chairman/Authority Vice Chairman Dear offered additional comments.

#### Daniel Valdez

Spoke about draft maps he provided to the City Manager and City Council for their review.

Mayor Pro Tem/Agency Vice Chairman/Authority Vice Chairman Dear requested staff to work with demographer, Mr. Johnson, to consider adding population units to the district maps.

#### Fe Koons, Carson resident

Spoke about district maps. Reported graffiti on benches at Dolphin Park; and suggested cameras be placed at parks.

Council Member/Agency Member/Authority Board Member Davis-Holmes noted the importance of adhering to the timeline and provided handouts to City Council and staff.

Spoke about diversity.

Spoke about the opportunity for fair share in the workforce, concurring with previous speaker.

#### Dr. Leandrea Fields-Robinson, Carson resident

Spoke about heavy truck traffic and multiple accidents on Helmick and Wilmington Avenue; inquired about installing a traffic light and speed bumps at that location.

Mayor/Agency Chairman/Authority Chairman Robles noted traffic lights are part of the Capital Improvement Project. He directed speaker to contact Director of Public Works, Williams-Slaughter to request speed bumps.

Council Member/Agency Member/Authority Board Member Davis-Holmes noted fifty one percent of residents on Helmick Street will need to sign a petition requesting speed bumps, and then submit to the City Council.

Spoke about trucks speeding on Main Street and detour sign on Main Street at the 405 freeway.

Mayor/Agency Chairman/Authority Chairman Robles stated he would contact Captain Skeen to increase enforcement on Main Street. He directed Public Works to increase the detour sign

visibility then come back with options.
