

RESOLUTION NO. 20-025

A RESOLUTION OF THE CARSON CITY COUNCIL AMENDING THE
FISCAL YEAR 2019-20 BUDGET IN THE TRANSPORTATION
DIVISION FOR A COMPREHENSIVE OPERATIONS ANALYSIS OF THE
CARSON CIRCUIT

WHEREAS, the City Council adopted the City's Fiscal Year (FY) 2019-20 budget on June 18, 2019 for the General Fund & Special Revenue Funds of the City via Resolution No. 19-120; and

WHEREAS, The City of Carson operates the Carson Circuit, a fixed-route public transit system that services defined areas of the City; and

WHEREAS, Staff is in negotiations with Long Beach Transit to provide fixed-route bus services to the City of Carson; and

WHEREAS, A Comprehensive Operations Analysis of the current Carson Circuit routes is imperative to determine operational efficiencies before entering into such agreement; and

WHEREAS, funds in the amount of \$74,580 will be used to pay the anticipated costs for the Comprehensive Operations Analysis; and

WHEREAS, the City Council desires to amend FY 2019-20 budget; and

WHEREAS, the City Council has determined it necessary to amend the FY 2019-20 budget.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF CARSON DOES HEREBY RESOLVE, FIND, DETERMINE, AND ORDER AS FOLLOWS:

Section 1. The following amendments will be made to the City's budget:
