## A RESOLUTION OF THE CITY OF CARSON CITY COUNCIL AMENDING THE FISCAL YEAR 2019-20 BUDGET IN THE GENERAL FUND

**WHEREAS**, estimated General Fund revenue has increased significantly, primarily due to nonrecurring receipts; and

**WHEREAS,** the City Council has determined it necessary to amend the Fiscal Year 2019-2020 budget.
