

RESOLUTION NO. 20-012

**A RESOLUTION OF THE CITY OF CARSON CITY COUNCIL AMENDING THE
FISCAL YEAR 2019-20 BUDGET IN THE GENERAL FUND AND IN THE ADMIN TOW FEE FUND**

WHEREAS, the City Council adopted the Fiscal Year 2019-20 (FY19-20) budget on June 18, 2019 for the General Fund and Special Revenue Funds of the City via Resolution No. 19-120; and

WHEREAS, the City has awarded a building services contract to American Guard Services, Inc. to provide building security services commencing on June 1, 2018 (the "Effective Date"), and expiring May 31, 2021; and

WHEREAS, the City Council approved the addition of one security officer from June 1, 2018 to May 31, 2019; and

WHEREAS, the City Council approved the overtime hours work of the Supervisor; and

WHEREAS, the City Council approved the addition of 80 service hours/week from May 2019 up to the end of the term; and

WHEREAS, the City Council approved the transfer of \$75,000 from the Restricted Admin Tow Fee Fund to the General Fund; and

WHEREAS, the City Council approved the appropriation of \$51,150.00 from the Unassigned and Uncommitted General Fund Balance to increase the Public Safety Facilities Security Professional Services account; and

WHEREAS, the City Council has determined it necessary to amend the FY19-20 General Fund budget and the Admin Tow Fee Fund.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF CARSON DOES HEREBY RESOLVE, FIND, DETERMINE, AND ORDER AS FOLLOWS:

Section 1. The following amendment(s) will be made to the City's FY19-20 budget.
