AMENDMENT NO. 1

TO AGREEMENT FOR CONTRACTUAL SERVICES

THIS AMENDMENT TO THE AGREEMENT FOR CONTRACTUAL SERVICES ("Amendment") by and between the CITY OF CARSON ("City") and HR&A ADVISORS, INC., a New York corporation ("Consultant") is effective as of the 19th day of June, 2019.

RECITALS

- A. City and Consultant entered into that certain Agreement for Contractual Services dated June 19, 2018 ("Agreement") whereby Consultant agreed to provide on-call economic and fiscal impact Services.
- B. The Agreement provided the City with the option, at its sole discretion, to extend the term of the agreement for up to two additional one-year terms.
- C. City has determined that it wishes to exercise the first of its two one-year options to extend the agreement, in accordance with the Agreement.
- D. City and Consultant, to facilitate City's exercise of the option, now desire to: 1) extend the term of the agreement for one additional year, From June 19, 2019 through June 18, 2020; 2) for the sum of not-to-exceed \$100,000; and 3) authorize the contract officer to exercise the second one-year option, if so desired by the City.

TERMS

1. **Contract Changes.** The Agreement is amended as provided herein (new text is identified in *bold italics*, deleted text in strike through).

3.4 Term.

Unless earlier terminated in accordance with Article 7 of this Agreement, this Agreement shall continue in full force and effect until completion of the services but not exceeding one (1) year from the date hereof, except as otherwise provided in the Schedule of Performance (Exhibit "D"). City may, in its sole discretion, extend the Term for two additional one-year extensions. If the City, in its sole discretion, elects to extend the Term for one or both of the two additional one-year extensions, the Contract Officer shall have the authority to do so.

4.3 Contract Officer.

The Contract Officer shall be Alvie Betancourt, Planning Manager Richard-Rojas, Acting Planning Manager, or such person as may be designated by the Community Development Director. It shall be the Consultant's responsibility to assure that the Contract Officer is kept informed of the progress of the performance of the services and the Consultant shall refer any decisions which must be made by City to the Contract Officer. Unless otherwise specified herein, any approval of City required hereunder shall mean the approval of the Contract Officer. The Contract Officer shall have authority, if specified in writing by the City Manager, to

sign all documents on behalf of the City required hereunder to carry out the terms of this Agreement.

- 2. **Continuing Effect of Agreement.** Except as amended by this Agreement, all provisions of the Agreement shall remain unchanged and in full force and effect. From and after the date of this Amendment, whenever the term "Agreement" appears in the Agreement, it shall mean the Agreement, as amended by this Amendment to the Agreement.
- 3. Affirmation of Agreement; Warranty Re Absence of Defaults. City and Consultant each ratify and reaffirm each and every one of the respective rights and obligations arising under the Agreement. Each party represents and warrants to the other that there have been no written or oral modifications to the Agreement other than as provided herein. Each party represents and warrants to the other that the Agreement is currently an effective, valid, and binding obligation.

Consultant represents and warrants to City that, as of the date of this Amendment, City is not in default of any material term of the Agreement and that there have been no events that, with the passing of time or the giving of notice, or both, would constitute a material default under the Agreement.

City represents and warrants to Consultant that, as of the date of this Amendment, Consultant is not in default of any material term of the Agreement and that there have been no events that, with the passing of time or the giving of notice, or both, would constitute a material default under the Agreement.

- 4. Adequate Consideration. The parties hereto irrevocably stipulate and agree that they have each received adequate and independent consideration for the performance of the obligations they have undertaken pursuant to this Amendment.
- 5. Authority. The persons executing this Agreement on behalf of the parties hereto warrant that (i) such party is duly organized and existing, (ii) they are duly authorized to execute and deliver this Agreement on behalf of said party, (iii) by so executing this Agreement, such party is formally bound to the provisions of this Agreement, and (iv) the entering into this Agreement does not violate any provision of any other Agreement to which said party is bound.
