Dear Mr. Coupal:

I am the City Attorney for the City of Carson ("City"), and I am writing to you in reference to your letter dated August 24, 2020, concerning the City's activities and expenditures in relation to the City's sales tax measure placed on the November 3, 2020, general municipal election ("Letter"). Thank you for your concern and for reaching out to the City on this important issue.

The City understands the importance of ensuring that public funds are not utilized to advocate for or against the City's proposed sales tax measure for the November 3, 2020, general municipal election ("Sales Tax Measure") and the City has no intention of utilizing public funds for such purposes. However, it is important that City residents know and understand how the Sales Tax Measure works, the City's fiscal status, and other similar information in order to make an informed decision. As such, the City plans to engage in important informational activities in relation to the Sales Tax Measure as permitted by applicable law.<sup>1</sup>
