

RESOLUTION NO. 20-179

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
CARSON, CALIFORNIA AUTHORIZING THE UTILIZATION
OF KEN PORTER AUCTIONS TO FACILITATE THE SURPLUS
SALE OF TWENTY FIVE (25) CITY VEHICLES AND
EQUIPMENT**

WHEREAS, Vehicle and Equipment No. 717, 767, 790, 992, 1049, 1075, 969, 1141, 1178, 1179, 1212, 1261, 1260, 1048, 1108, 1159, 1239, 1270, 1276, 1291, 1293, 1324, 1328, 1337 and No. 802 and have exceeded their useful life; and

WHEREAS, all twenty five (25) City vehicles and equipment are taking up limited space at the City's new Corporate Yard, and pose a safety hazard to staff and other vehicles; and

WHEREAS, per Carson Municipal Code, Section 2614 (d) (2), DISPOSITION OF SURPLUS PROPERTY:

“(d) Auction. If the Purchasing Manager elects to dispose of surplus property by auction, the following procedures shall be used:

(2) Surplus property shall be sold to the highest bidder at a public auction conducted by a licensed auctioneer or through participation in a cooperative auction of government agencies.”

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF CARSON DOES HEREBY RESOLVE, FIND, DETERMINE, AND ORDER AS FOLLOWS:

Section 1. Ken Porter Auctions shall be designated to facilitate the sale of Vehicles and equipment No. 717, 767, 790, 992, 1260, 1049, 1075, 969, 1141, 1178, 1179, 1212, 1261, 1048, 1108, 1159, 1239, 1270, 1276, 1291, 1293, 1324, 1328, 1337 and No. 802

Section 2. Any proceeds from the sale of Vehicles and equipment mentioned will be apportioned accordingly to the City's Equipment Replacement Fund Account No. 638-99-999-999-803.
