RESOLUTION NO. 21-002

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CARSON, CALIFORNIA, RECITING THE FACT OF THE GENERAL MUNICIPAL ELECTION HELD ON NOVEMBER 3, 2020, THE RESULTS FOR CONTEST OF MAYOR, THE CITY COUNCIL, BALLOT MEASURE (SALES TAX) AND SUCH OTHER MATTERS AS PROVIDED BY LAW.

WHEREAS, a General Municipal Election was held and conducted in the City of Carson, California, on Tuesday, November 3, 2020, as required by law; and

WHEREAS, notice of the election was given in time, form and manner as provided by law; that voting precincts were properly established; that election officers were appointed and that in all respects the election was held and conducted; the votes were cast, received and canvassed and the returns made and declared in time, form and manner as required by the provisions of the Elections Code of the State of California for the conduct of elections in general law cities; and

WHEREAS, the Los Angeles County Registrar-Recorder/County Clerk canvassed the returns of the election and has certified the results to this City Council, the results are received, attached and made a part of hereof as "Exhibit A".

WHEREAS, the Los Angeles County Registrar-Recorder/County Clerk canvassed the returns of the election and has certified the results to this City Council, the results are received, attached and made a part of hereof as "Exhibit B".

NOW, THEREFORE, THE CITY COUNCIL OF CARSON DOES HEREBY RESOLVE, FIND, DETERMINE, AND ORDER AS FOLLOWS:

Section 1. That the whole number of ballots cast in the precincts except vote by mail voter ballots was 9,066. The whole number of vote-by-mail voter ballots cast in the City was 36,710, making a total of 45,776 ballots cast in the City of Carson.

Section 2.

That the names of persons voted for at the election for Mayor of the City of Carson, are as follows:

Falea'ana "Ana" Meni Lula Davis-Holmes Jim Dear Albert Robles

That the names of persons voted for at the election for Member of the City Council, District 1, are as follows:

That the measure voted upon at the election is as follows:

CARSON ESSENTIAL CITY SERVICES, EMERGENCY RESPONSE PROTECTION MEASURE. To maintain City services, such as public safety, natural disaster/public health emergency preparedness; 9-1-1 emergency response, protect local drinking water/environment;	YES
assist local small businesses/retain jobs; repair streets/potholes; and other general City services, shall the measure establishing a ¾-cent general transaction and use (sales) tax providing Carson approximately \$12,000,000 annually until ended by voters, requiring public spending disclosure, all funds for Carson, be adopted?	NO

Section 3. That the number of votes given at each precinct and the number of votes given in the for and against the measure were as listed in Exhibit "B" attached.

Section 4. The City Council does declare and determine that:

LULA DAVIS-HOLMES was elected Mayor for the full term ending, November 2024;

JAWANE HILTON was elected as Member of the City Council, District 1, for the term ending November 2024;

CEDRIC L. HICKS, SR. was elected as Member of the City Council, District 3, for the full term ending November 2024;

As a result of the election, a majority of the voters voting on the measure relating to ORDINANCE NO. 20-2009, AN ORDINANCE OF THE PEOPLE OF THE CITY OF CARSON ADDING CHAPTER 1.5 TO ARTICLE 6 OF THE CARSON MUNICIPAL CODE, THEREBY ESTABLISHING A GENERAL TRANSACTIONS AND USE TAX AT THE RATE OF .75% did vote in favor of it, and that the measure was carried, and shall be deemed adopted and ratified.

- **Section 5.** The City Clerk shall enter on the records of the City Council of the City, a statement of the result of the election, showing (1) the whole number of ballots cast in the City; (2) the measure voted upon; and (3) the total number of votes given at each precinct for and against the measure.
- **Section 6.** That the City Clerk shall immediately make and deliver to each of the persons so elected a Certificate of Election signed by the City Clerk and authenticated; that the City Clerk shall also

administer to each person elected the Oath of Office prescribed in the Constitution of the State of California and shall have them subscribe to it and file it in the office of the City Clerk. Each and all of the persons so elected shall then be inducted into the respective office to which they have been elected.

Section 7. That the City Clerk shall certify to the passage and adoption of this resolution and enter it into the book of original resolutions.
