

RESOLUTION NO. 21-020

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CARSON, CALIFORNIA, AMENDING THE FISCAL YEAR 2020/21 BUDGETS IN THE TRANSPORTATION DEVELOPMENT ACT ARTICLE III FUND AND THE DEVELOPMENT IMPACT FEE FUND TO PURCHASE CONCRETE PICNIC TABLES, BARBECUES, AND CHARCOAL RECEPTACLES FOR VARIOUS CITY PARKS

WHEREAS, the City Council adopted the Fiscal Year 2020/21 budget on June 16, 2020; and

WHEREAS, several amenities – picnic tables, barbecues, and charcoal receptacles - at various City parks have outlived their useful life and need to be replaced; and

WHEREAS, the Los Angeles County Metropolitan Transportation Authority maintains the City's FY2017 Transportation Development Act Article III (TDA3) Fund, and has \$61,717 that will lapse if not fully spent and drawdown by May 31, 2021; and

WHEREAS, the City desires to use these TDA3 funds towards the purchase of concrete picnic tables; and

WHEREAS, the City desires to utilize available Development Impact Fee (DIF) funds in the amount of \$27,000 for the purchase of additional concrete picnic tables, barbecues, and charcoal receptacles; and

WHEREAS, the City now desires to amend the FY 2020/21 budget.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF CARSON DOES HERBY RESOLVE, FIND, DETERMINE, AND ORDER AS FOLLOWS:

**Section 1.** The following amendments(s) will be made to the City's Fiscal Year 2020/21 budget.
