

RESOLUTION NO. 21-013

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CARSON, CALIFORNIA, ACCEPTING A \$68,000 GRANT FROM THE SOUTH BAY CENTER FOR COUNSELING TO SUPPORT THE PREVENTION AND AFTERCARE PROGRAM.

WHEREAS, the City Council adopted the City’s Fiscal Year (FY) 2020-21 budget on June 16, 2020; and

WHEREAS, the South Bay Center for Counseling (SBCC) has been providing funds for the Prevention and Aftercare Program (“Program”) since 2015; and

WHEREAS, the Program is designed to strengthen family resilience and nurture the development of healthy behaviors; and

WHEREAS, the City has historically been notified in January of the amount of Program funding it will receive for that calendar year. However, due to pandemic-related challenges that impacted its ability to execute grant renewals in a timely manner, as of January 2021 SBCC was able to offer Program funding for only the first two months of 2021; and

WHEREAS, on January 26, 2021, the City Council accepted grant funds in the amount of \$10,000 to underwrite the Program for the months of January and February 2021; and

WHEREAS, the City was recently notified that it will be receiving \$68,000 in grant funding from SBCC for the Program through June 30, 2022; and

WHEREAS, the City Council now desires to accept the foregoing Program funding award, and amend the FY 2020-21 budget to include Program funding in the amount of \$17,000 and allocate the balance of the funds to FY 2021/22.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF CARSON, CALIFORNIA, DOES HEREBY RESOLVE, FIND, DETERMINE, AND ORDER AS FOLLOWS:

Section 1. The award of grant funding from SBCC in the amount of \$68,000 for the Program through June 30, 2022 is hereby accepted.

Section 2. The following amendments will be made to the City’s budget based on the award:
