RESOLUTION NO. 21-053

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CARSON, CALIFORNIA, APPOINTING MOLLY MCLAUGHLIN PERRY AS INTERIM CHIEF DEPUTY CITY CLERK AND AUTHORIZING CITY MANAGER TO EXECUTE EMPLOYMENT AGREEMENT

WHEREAS, Government Code Sections 21221(h) and 7522.56 permit retired annuitants under the California Public Employees' Retirement System ("CalPERS") to be employed without reinstatement from retirement upon appointment by a governing body to fill a vacant position on an interim basis during the recruitment to permanently fill the vacant position; and

WHEREAS, the City's Chief Deputy City Clerk position has been vacant since January 7, 2021 and the City is currently conducting a recruitment to fill this position; and

WHEREAS, as a CalPERS retired annuitant under Government Code Section 21221(h), Molly McLaughlin Perry possesses extensive experience as a City Clerk and possesses the specialized skill set to perform the required duties of Interim Chief Deputy City Clerk and desires to perform the duties of, and assume responsibility for, the position of Interim Chief Deputy City Clerk and acknowledges that such employment is at-will and of a limited duration for a definite period of time, as described below; and

WHEREAS, concurrent with the adoption of this resolution, the City Council has adopted a resolution approving a 180-day wait period exception for Ms. McLaughlin Perry; and

WHEREAS, the City desires to hire Ms. McLaughlin Perry as an at-will, limited duration employee for the position of Interim Chief Deputy City Clerk, which is a position that requires specialized skills, for a definite period of time, effective April 21, 2021.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF CARSON DOES HEREBY RESOLVE, FIND, DETERMINE, AND ORDER AS FOLLOWS:

- **SECTION 1.** The City Council does hereby declare that the above recitals are true and correct and are incorporated herein by this reference.
- **SECTION 2.** The City Council hereby approves the appointment of Molly McLaughlin Perry as the Interim Chief Deputy City Clerk for the City of Carson.
- **SECTION 3.** The City Council hereby approves the Limited Duration Interim Chief Deputy City Clerk Employment Agreement between the City of Carson and Molly McLaughlin Perry, attached hereto as Exhibit "A".
