

RESOLUTION NO. 21-066

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CARSON,
CALIFORNIA, AUTHORIZING THE DESTRUCTION OF SPECIFIED CITY
RECORDS WITHIN THE FINANCE DEPARTMENT**

THE CITY COUNCIL OF THE CITY OF CARSON, CALIFORNIA, HEREBY RESOLVES AS FOLLOWS:

WHEREAS, Title 4, Division 1, Chapter 4, Section 34090 of the California Government Code, provides for the destruction of certain city records that are greater than two (2) years old and not otherwise required by law to be retained for a longer period; and

WHEREAS, Part 2, Title 2, Chapter 3, Section 337 of the California Code of Civil Procedure provides a retention of certain records for their audit date plus four (4); and

WHEREAS, Title 5, Division 2, Part 1, Chapter 4, Article 1 of the California Government Code provides for the permanent retention of certain records of investment transactions; and

WHEREAS, the City of Carson's City Attorney has reviewed the description of the records proposed for destruction and approved the destruction of the records itemized in Exhibit "A" to this Resolution as compliant with state law; and

WHEREAS, the City of Carson's Director of Finance has approved the proposed destruction of all the records itemized on Exhibit "A" to this Resolution without microfilming or reproduction; and

WHEREAS, the City of Carson's Records Management Committee Chairman has approved the proposed destruction of all the records itemized on Exhibit "A" to this Resolution; and

WHEREAS, the City of Carson's City Manager has approved the proposed destruction of all the records itemized on Exhibit "A" to this Resolution; and

NOW, THEREFORE, the City Council of the City of Carson, California does hereby resolve and authorize the destruction of the records listed on Exhibit "A" to this Resolution without further action by the City Council of the City of Carson.
