## A RESOLUTION OF THE CITY OF CARSON CITY COUNCIL ADOPTING THE FISCAL YEAR 2021-22 BUDGET IN THE GENERAL FUND AND SPECIAL REVENUE FUNDS

WHEREAS, the City Council has determined it necessary for efficient management of the City to appropriate certain sums in various departments for various activities of the City.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF CARSON DOES HEREBY RESOLVE, FIND, DETERMINE, AND ORDER AS FOLLOWS:

- **Section 1.** The General Fund budget and Special Revenue Funds budget for the City of Carson beginning July 1, 2021 and ending June 30, 2022 is hereby adopted. Said budget being the proposed budget as reviewed and amended by the City Council, a copy of which is on file in the City Clerk's Office.
- **Section 2.** The funds are hereby appropriated to the respective accounts for expenditure in FY21-22, as set forth in the proposed and amended budget.
- **Section 3.** The following sums of money are hereby appropriated to the following departments of the City for expenditure during FY21-22.
