A RESOLUTION OF THE CARSON CITY COUNCIL AMENDING THE FISCAL YEAR 2021-22 COMMUNITY DEVELOPMENT DEPARTMENT BUDGET TO ADD FUNDING FOR THE SOUTHERN CALIFORNIA HOUSING RIGHTS CENTER AND THE BOYS & GIRLS CLUBS OF CARSON

WHEREAS, The City Council adopted the Community Development Block Grant (CDBG) 2021-2022 Annual Action Plan on April 20, 2021; and

WHEREAS, the City Council adopted the City's Fiscal Year 2021-22 budget on June 15, 2021; and

WHEREAS, in adopting said Annual Action Plan, the City Council allocated \$37.500.00 in CDBG funds and an additional \$2,500.00 from the General Fund for the Southern California Housing Rights Center, and allocated \$34,828.00 in CDBG funds and an additional \$15,172.00 from the General Fund to the Boys & Girls Clubs of Carson.

WHEREAS, the City wishes to budget the General Fund dollars that were allocated to the aforementioned service providers.

WHEREAS, the City Council desires to amend the FY 2021-22 budget to authorize the use of funds from the Unreserved Budget to provide this funding.

NOW, THEREFORE. THE CITY COUNCIL OF THE CITY OF CARSON DOES HEREBY RESOLVE, FIND, DETERMINE, AND ORDER AS FOLLOWS:
