- Attended the Tip a Cop fundraising event on June 27, 2023
- Spoke with newly hired interns and shared information about sexual harassment, drug use, workplace violence, and safety
- Attended Coffee with a Cop event at Starbucks located on Bonita Street
- Deputy Quinn Alcones will be recognized by Mothers Against Drunk Driving at their Law Enforcement and Prosecution Recognition Awards
- On July 12, 2023, the Carson Sheriff's Department will be partnering with the city for a Blood Drive
- Thanked all sworn and professional staff at the Carson Station who worked the 4th of July and 4th of July weekend
- Deputies responded to 160 service calls related to illegal fireworks, excluding the selfinitiated proactive police work, arrested one person for felony possession of over 100 pounds of illegal fireworks and another arrest for possession of a firearm, confiscated over 1,060 pounds of illegal fireworks and issued approximately \$108,000 in total fines

City Clerk/Agency Secretary/Authority Secretary, Dr. Bradshaw gave the Public Hearing report.

Mayor/Agency Chairman/Authority Chairman Davis-Holmes declared the Public Hearing open.

City/Agency/Authority Attorney Soltani gave a presentation.

Council Member/Agency Member/Authority Board Member Dear inquired about how mobilehome park owners would be compensated for the loss of value in their coach if they are relocated to a location that does not have rent stabilization.

City/Agency/Authority Attorney Soltani stated that mobilehome park owners can receive a lump sum value of their coach or decide if they want to relocate to a location that does not have rent control. She also insisted that the new ordinance now offers more flexibility to City Council to consider a stipend and other fair options.

Jeff Steinman

Expressed concerns about the zoning ordinance and how it may be ambiguous

Bill Smalley

Offered comments about the zoning ordinance and asked City Council to approve the amended ordinance to reflect the state's changes

Socorro Magana (assisted by Spanish translator)

Residents of Rancho Dominguez mobilehome park are still being harassed and asked to relocate by December of this year; City/Agency/Authority Attorney Soltani stated that a letter would be sent to the park owner, if requested by City Council, informing the owner to not confuse residents with misinformation and that the park is not closing; also stated that there are no park

managers on site and catalytic converters have been stolen.

Mayor/Agency Chairman/Authority Chairman Davis-Holmes instructed the speaker to speak to Captain Jones regarding the issue of stolen catalytic converters.

Mayor/Agency Chairman/Authority Chairman Davis-Holmes instructed City/Agency/Authority Attorney Soltani to copy the HOA president on the outgoing letter.

Leanor Gonzalez

Expressed concerns about Item No. 21. She also stated that there needs to be a Spanish translated notice.

Mayor Pro Tempore/Agency Vice Chairman/Authority Vice Chairman, Dr. Hilton requested to be tagged on Facebook post showing the people blowing bullhorns in the mobilehome park.

Council Member/Agency Member/Authority Board Member Rojas apologized to Leanor for the events that took place at Park Avalon and the misinformation that's been passed around.

Rick Pulido

Expressed concerns about Item No. 21; referred to the morale of the city.

Sherri Hodges

Stated that her and the residents of her mobilehome park failed to receive the notice. Expressed concerns of housing for the homeless; didn't receive any email about the City Council meeting schedule; simplify the language of notices so that everyone can better understand; expressed concerns about traffic congestion

Mayor/Agency Chairman/Authority Chairman Davis-Holmes referred Sherry Hodges to City Manager Roberts, Jr. for information regarding the receiving City Council meeting email notices.

Daniel Valdez

Clarified with City Council that he informed residents that Avalon Park was once closing but no longer is; addressed the constant/excessive improvements at Avalon Park.

Phil Dumbrique

Inquired about where mobilehome park residents of Bel-Aire Park would possibly be relocated and who would be paying for the relocation

Kenneth (last name not provided) (written communication)

Requested City Council to use direct and precise language when amending city ordinances or laws

Mayor/Agency Chairman/Authority Chairman Davis-Holmes declared the Public Hearing closed.

Council Member/Agency Member/Authority Board Member Dear requested a motion to change the notice of termination period of AB 2782 from 120 days to 180 days.

Council Member/Agency Member/Authority Board Member Dear requested a second motion to amend the verbiage of section E7 of Ordinance 23-2304 to protect and ensure residents will be

relocated to a mobilehome park with rent control.

City/Agency/Authority Attorney Soltani made the following amendments to section E7:

"A requirement that a resident who cannot obtain housing in another rent controlled mobilehome park within 50 miles of the current park be compensated by a lump sum payment equal to the in-place market value of the displaced resident's mobile home"

Council Member/Agency Member/Authority Board Member Dear made a third motion as requested by the Planning Commission to include additional language that states a survey question needs to be included to inquire whether residents support the proposed conversion of the park.

City/Agency/Authority Attorney Soltani confirmed all motions made by Council Member/Agency Member/Authority Board Member Dear are consistent with state law.

City/Agency/Authority Attorney Soltani made modifications to the presented ordinance to meet the intent of the legislation.
