Item No. 3

OVERVIEW OF PROPOSITION 64 (THE ADULT USE OF MARIJUANA ACT) AND CONSIDERATION OF CITY ACTION CONCERNING PROPOSITION 64, INCLUDING POSSIBLY SENDING BALLOT MEASURES TO THE CARSON VOTERS TO REGULATE, RESTRICT, AND/OR TAX ALL CANNABIS RELATED BUSINESS AND ACTIVITIES WITHIN THE CITY OF CARSON (CITY COUNCIL)

Item No. 3 was heard after Item No. 4 at 5:27 P.M.

City Manager Farfsing presented the staff report.

City Attorney Soltani discussed Proposition 64.

(Mayor Robles exited the meeting at 5:31 P.M. and reentered the meeting at 5:33 P.M.)

Assistant City Attorney Neumeyer provided a PowerPoint presentation of the Proposed Marijuana Ballot Measures - California Law.

(Council Member Santarina exited the meeting at 5:55 P.M. to attend the Vector Control meeting.)

A discussion ensued regarding tax on marijuana businesses.

Recommendation:

REVIEW the information in this staff report and TAKE one or more of the following actions:

- DIRECT staff to take no immediate action, with understanding that further direction may be provided at a future date and prior to 2018, if AUMA passes;
- DIRECT staff to prepare an ordinance for Council consideration to prohibit all marijuana activities within the City of Carson with the exception of the activities which will be expressly allowed and authorized by AUMA and City does not have legal authority to prohibit pursuant to AUMA;
- DIRECT staff to prepare an ordinance for Council consideration to restrict and regulate some or all of the medical marijuana operations currently allowed under state law and/or, contingent on passage of AUMA, some or all of the nonmedical marijuana businesses (which will be allowed under state law if AUMA passes).
- 4. CONSIDER sending ballot measures for consideration to the voters regulating and restricting all cannabis related businesses and activities and/or taxing same.

ACTION: It was moved to Waive further reading and Adopt Resolution Nos. 16-115, 16-116, and 16-117, with the modification to change the tax up to 18%, on motion of Davis-Holmes, seconded by Robles and unanimously carried by the following voice vote:

City Attorney Soltani stated that she would provide the proper language modification and present to the Council later in the meeting.

At 6:40 P.M. after Oral Communications (Council Members), City Attorney Soltani stated that she would clarify the wording of the ballot measure to the Carson voters to include the following: 1) Shall a future Council or voters of Carson approve permitting cannabis business activities; 2) \$25 per square foot space utilize for cultivation; 3) 18% of gross proceeds on all cannabis related businesses and activities in Carson to be adjusted annually July 1 CPI; and 4) Annual revenues of \$500,000 to \$3.5 million of Carson with no sunset be approved. She further stated that she would still need to work with language because of word count issue.

Mayor Robles requested that City Attorney Soltani provide the language in final form to the Mayor and Council Members.

Upon request, City Attorney Soltani also clarified that the City Council was not sending any ordinance to the voters that would legalize, permit, regulate, and that cannabis businesses in the City of Carson would be status quo and that the only matter sending to voters is shall a future Council change that or shall voters do a voter initiated measure to legalize it in the City, to that nature and under that circumstance there would be a 18% tax that would be in place, if passed in November 2016 election, and \$25 per square foot on cultivation, which there was a distinction yet to be clarified.

CONSIDERATION OF CONSOLIDATION OF THE CARSON GENERAL MUNICIPAL ELECTION WITH THE STATEWIDE GENERAL ELECTION TO BE CONDUCTED BY THE COUNTY OF LOS ANGELES ON TUESDAY, NOVEMBER 8, 2016

Item No. 5 was heard after Oral Communications (Members of the Public) at 5:08 P.M.

(Council Member Hilton reentered the meeting at 5:09 P.M.)

City Attorney Soltani summarized the staff report.

Recommendation:

- 1. CONSIDER adopting Resolution No. 16-111 confirming and affirming the consolidation of the Carson General Municipal Election with the Statewide General Election to be conducted by the County of Los Angeles on Tuesday, November 8, 2016.
- 2. REPEAL Resolution No. 16-085, "A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CARSON, CALIFORNIA, REQUESTING THE BOARD OF SUPERVISORS OF THE COUNTY OF LOS ANGELES TO RENDER SPECIFIED SERVICES TO THE CITY RELATING TO THE CONDUCT OF A GENERAL MUNICIPAL ELECTION TO BE ADMINISTERED BY THE CITY'S ELECTION OFFICIAL AND HELD ON TUESDAY, NOVEMBER 8, 2016."

ACTION: It was moved to request that the Los Angeles County Registrar-Recorder Office make signs sufficiently big that would be easily noticeable for the voters; email blast to Carson registered voters and robocall to voters to advise them about the election ballot on motion of Robles.

Council Member Hicks requested to add a type of separation between the elections to identify clearly City of Carson election and to go back to original poll locations to ensure that the voters know where to vote.

Mayor Robles amended his motion to incorporate the additional request from Council Member Hicks to have a specific page that would separate the Carson Municipal Election from the County election and give sufficient notice to the Carson voters that the polling places were going to be familiar from the past to the fullest extent possible and seconded by Hicks.

During discussion of the motion, City Clerk Gause discussed the issue of the Voter Information Pamphlet that the County uses was small and that the Carson voters were accustomed to the 8-1/2 x 11 size pamphlet. She stated that the County shared a sample of the City of Santa Monica Voter Information Pamphlet that they send to their voters separately and who were also on the ballot with the County.

She further stated that she would need direction from City Council to mail a separate Voter Information Pamphlet to the Carson voters due to the fiscal impact involved.

Mayor Robles requested that City Clerk Gause bring back a budget of the Voter Information Booklet at the next Council meeting.

City Attorney Soltani clarified that the Council could request the additional items but there was no guarantee that the County of Los Angeles would do so.

It was moved to 1) Adopt Resolution No. 16-111 and 2) Repeal Resolution No. 16-085, on motion of Robles and seconded by Hicks.

The motion, as amended, was unanimously carried by the following vote:
