Julie Ruiz-Raber

Spoke about her appreciation for her husband Brian Raber who is a military veteran. She announced an upcoming event at Angel Stadium honoring military veterans where her husband was asked to carry the United States Flag. She also congratulated and welcomed the newly appointed City Manager, Sharon Landers.

Brian Raber - Chairman of the Veterans Affairs Commission

Spoke about the lack of Veterans Affairs Commission meetings because of absenteeism. He also spoke about the commissions' efforts preparing for the Veteran's Day Ceremony.

Tommie Williams

Requested updates to Broadacres Elementary School. Ms. Williams inquired about plans for development on the corner of Central Avenue and University Drive. She requested a supermarket.

Mayor Robles noted he reached out to Superintendent Romero to schedule tour of Broadacres Elementary School.

Council Member Hilton stated the lack of roof tops in this specific area will not support a super market opening. He announced the upcoming State of Education address at Carson Community Center hosted by Community of Schools Director, Dr. Adaina Brown. He recommended Ms. Williams address her questions about Broadacres Elementary School at that time. He stated he will ask Public Information Office to work on flyers to inform the residents.

Speaker – Disabled Veteran

Spoke about damage to his car caused by a pothole on Avalon Boulevard south of the 405 freeway. He submitted his claim seven months ago and has not heard back from the city. He asked why the process takes so long and requested a response.

Mayor Robles apologized for the delay. He concurred with the speaker and directed him to meet with City Manager Landers to address his issue.

Patricia Patterson

Inquired about the reason the City is considering a change to district-based voting.

Mayor Robles explained the basis of the lawsuit and announced the next Public Hearing to be held on September 17, 2019 at 6:00 P.M.

Council Member Davis-Holmes noted a letter sent to the City threatening a lawsuit.

Kim Cortado, Parks and Recreation Commissioner

Provided copies of the Fall Issue of the Carson Report and Community Services Guide to the Mayor and City Council. Announced programs at a glance throughout the City. She mentioned the successful James Foisia Renaming Ceremony.

Robert Lesley

Concerned about density impacts related to various projects throughout the city noting the Central and Victoria, Complex at Victoria Park, Del Amo and Main, and the project adjacent to the Dominguez Hills homes. He spoke about traffic impacts. He requested more studies be done. He mentioned how to remediate wells, gas lines and cell dish. He stated the City should be more conscientious providing information and notifications about proposed projects.

Mayor Robles spoke about the groundbreaking of the Outlet Mall at the 157 acre site. He assured residents every precautionary measure is being taken to ensuring any developments built on the Brownfield site will meet all state regulatory requirements imposed on the City.

City Manager Landers noted the attempt to obtain the information about usage from the previous contractor which was unsuccessful. The new contract requires that data of usage be provided.

Mike Whittiker, Human Services Manager, noted there is a provision in the new contract stating the contractor is required to provide a monthly report.

Discussion ensued regarding the EARS program.

Amanda Valorisi, Senior Assisted Living Coordinator, offered additional comments regarding the EARS program.
