Mayor Robles stated Council Member Dear can meet with Human Resources Director Moseley to gain that knowledge.

Mayor Robles noted that Council Member Hilton was not properly served regarding the three Special Meetings held. He stated this meeting is a violation of the Brown Act. He then cited sections 313 and 602 of the City Charter. Mayor Robles then stated the meeting should not continue because of multiple City Charter violations.

City Attorney Soltani stated Item No. 7 and Item No. 10 both have ordinances and these items will be on the February 5, 2019 Agenda.

Item No. 5. 2019-084 REVIEW AND FILE THE CITY-WIDE DEPARTMENT ORGANIZATIONAL CHARTS

City Treasurer Cooper noted for the record that the Chief Deputy position has been filled and she is now recruiting to fill the Accountant II position.

Human Resources Director Moseley noted the organizational charts are not updated.

AFSCME Local 809 President Ana Meni spoke on Item No. 5. The organizational charts submitted to Council should not have had employee names listed to avoid any favoritism or retaliation issues. She also clarified the differences between an SMP and a CPP. She noted a meet and confer is required regarding Item No. 6. She also requested clarification on Item No.10.

Human Resources Director Moseley noted that the organizational charts can include names and she will contact AFSCME Local 809 President Ana Meni to meet and confer when necessary.

Carson Resident William Koons inquired about the information being provided on the Closed Session Items because he believes it is evasive. He also requested information on which Government Code is being cited. He noted the flyer circulated regarding the City Charter did not list the pros and cons.

Carson Resident Tommie Williams supports the Cannabis Initiative and states the positive connections to a natural remedy for pain.

Carson Resident Dianne Thomas thanked the new majority for bringing these items back up. Stated she supports medical marijuana but the City doesn't want marijuana manufactured or warehoused in Carson.

Carson Resident Robert Leslie noted the consensus at a series of townhall meetings held rejected the Cannabis Initiative. He is concerned about the negative impacts related to allowing the use of cannabis. He stated that no studies or CEQA process was done. He also noted Prop 64 and Prop 215 information.

Citywide Advisory Committee Commissioner Lori Carter Muhammad inquired about the fiscal ramifications if the City is sued by Focal Strategic Investments, LLC and California Processing Company, LLC in the event the Development Agreements are terminated. She also inquired if the applicants were informed about the meeting. She also opposes Item No. 11.

City Attorney Soltani confirmed that the applicants were informed.

Human Resources Director Moseley gave a brief staff report.

Council Member Davis-Holmes requested to work with Mayor Robles to create an Adhoc committee to review and develop an updated organizational chart.

Mayor Robles denied Council Member Davis-Holmes request because of the City Charter.

Council Member Davis-Holmes requested to eliminate the City Manager Assistant position and to start the meet and confer process with AFSCME 1017 to change the Community Liaison Representative and Senior Community Liaison positions to Field Representative and Senior Field Representative.

Council Member Dear inquired about the part-time position and whether or not it is represented and if it should be part of the meet and confer process.

Council Member Davis-Holmes inquired about the number of part-time positions in the Field Deputy Office. Staff responded that there is one part-time employee.

Recommendation: REVIEW AND FILE the department organizational charts.

It was moved to direct staff to meet and confer with AFSCME Local 1017 to eliminate one position and retitle two on motion of Davis-Holmes, seconded by Hicks and unanimously carried by the following vote:

Mayor Pro Tem Hicks states that there are several SMP's that need to be addressed.

Assistant City Manager Raymond clarified the cost of the two Senior Clerk positions. He also noted with the extended hours and the growing need for service makes it a reasonable expectation that the passport service acceptance fees will cover the two Senior Clerk fully loaded annual salaries.

A discussion ensued regarding California State University Dominguez Hills (CSUDH) passport services.

Council Member Davis-Holmes requested the fiscal and calendar year costs of the two fully loaded Senior Clerk positions and the number of clerical vacancies citywide.

Council Member Dear clarified his recollection of the history of the passport services at City Hall and stated he is interested in knowing the staff cost for fiscal year and whether or not the passport services pays for itself.
