Ray McKee - Website Public Comment Received January 3, 2021 – Non Agendized

Offered comments regarding the following: 1) Council to be mindful of pressing problems throughout the City; 2) Super Spreader events should not be allowed in Carson. The event at Victoria Park on New Year's Day was ridiculous! It should have been stopped before it reached the capacity that it did.; 3) Trees planted by the city on fairways are ruining the properties of residents who have invested their hard earned money. There are broken, uplifted sidewalks and roots growing into our lawn; 4) Who is enforcing the ordinances?; 5) Assist the grocery stores in getting large trash cans (or require that they provide them) which can be bolted to the cart return stations; 6) Council be about the business of all the people and work hard to look out for the safety and well-being of the city.

Sam Dacus Website Public Comment Received January 4, 2020 – Non-Agendized

Reported that on January 1, 2021 while he was on the golf course at Victoria Park, the park and surrounding streets were filled with motorcycles and classic cars. The street through the park was completely blocked by illegally parked vehicles. Most of the attendees were not wearing masks or social distancing. It took him some time to exit the golf course parking lot and a longer period of time to drive his way through the illegally parked vehicles to get to Avalon, a short

distance from the parking lot. While traveling that distance, he was intimidated by motorcycle riders. The event was a Super Spreader and was not limited to the park, but extended to the surrounding businesses. He was informed that similar occurrences are planned for future weekends. As a senior citizen of Carson and taxpayer, he is praying that the City ensures the necessary action is taken to avoid similar events.

Letter from Lisa H. Received January 4, 2021 – Non-Agendized

Inquired about the following: 1) If the City voted to have 12-year term limits (A measure to impose term limits on elected officials was on the ballot for Carson voters in Los Angeles County, California, on November 8, 2016 which was approved.) Who should enforce the rule?; 2) How can we change the rules to have the Mayor elected with a majority (50+) of the city's votes vs. 1/3?; 3) How do we change the City Attorney position into an elected position and how soon can this be accomplished?

Vivian Hauser - Website Public Comment Received January 5, 2021 – Non Agendized

Asked the City to do their homework before supporting any type of "homesharing" in the City of Carson. The neighborhood near Broadacres Elementary was a decent neighborhood until owners started renting out their properties and opening group homes. Most of the renters do not respect the neighborhood or the residents. They invite the wrong element into the neighborhood and create an unsafe environment. After a recent gang related shooting, a group of residents discussed whether the city and Sheriff's Department could warn owners about the risks of inviting strangers into their homes. We are the proud, beautiful city of Carson and we need affordable housing for those who desire to downsize and for their children who want to remain in Carson.
