Requested his proposed amendments to the Carson City Council's Resolution No. 21-037, condemning hate crimes in the City of Carson and statewide, as restated below for Council's deliberation and consideration, be read as follows:

"Whereas, under California Penal Code 422.6 PC, fines for hate crimes is up to \$5,000.00. Whereas, under California Penal Code 597 fines for cruelty to animals is up to \$20,000.

Whereas, California Victims' Bill of Rights Act – Marsy's Law does not necessarily cover and punish acts violative of California hate crimes laws and therefore, does not fully protect hate crimes victims.

Whereas, the value of human lives, safety, security, and welfare far exceed those of animals, it behooves penalties under hate crimes should be more severe and stiffer to secure the human lives, safety, security, and welfare.

Whereas, it is incumbent upon this City Council to make policies and adopt ordinance and/or recommend to California State Assembly or to the United Congress making criminal and civil penalties more severe and stiffer to prevent and eliminate hate crimes in all forms of violence, hate, discrimination, racism, harassment and xenophobia, and affirms its commitment to the reduction and elimination of these appalling ideologies.

Whereas, the City of Carson is a very diverse City that cherishes, upholds, and celebrates persons of all ethnicities, races, national origins, and backgrounds in our community.

Now, therefore, be it determined by the City Council of the City of Carson, California that: The City Council stands resolutely and indisputably against all forms of violence, hate, discrimination, racism, harassment and xenophobia, and affirms its commitment to the reduction and elimination of these appalling ideologies through City Council's adoption of policies, ordinance, and/or recommendations of legislations to California State Assembly and/or to the United States Congress increasing criminal and civil penalties against hate crimes from \$5,000.00 to \$25,000.00."

<u>Andrea - Public Comment Received April 6, 2021 – Item No. 30</u> Looking into the flavored tobacco issue not to happen. This is targeting young people that live in the city and have family members who are young and also live in the city. As menthol cigarettes are being pushed onto the community, would hope the City Council stand up for young people and ban flavored tobacco and do what is right for the community and the youth. Do not delay on this ban.
