Deputy City Clerk/Deputy Agency Secretary/Deputy Authority Secretary Simarago gave the Public Hearing Notice report.

Mayor Pro Tem/Agency Vice Chairman/Authority Vice Chairman Dear stated he appealed the decision of the Planning Commission and in concurrence with his colleagues that they are here in the interest of the residents.

Director Naaseh gave a PowerPoint presentation on the Appeal of Planning Commission Decision Approving Rancho Dominguez Mobile Estates Relocation Impact Report RIR No. 4-19.

Director Naaseh asked Interpreter Diana to read slides in Spanish.

Director Naaseh continued with his presentation.

Director Naaseh concluded his presentation. He thanked the City Attorney's Office for assisting staff on this matter, especially Assistant City/Agency/Authority Attorney Benjamin Jones and announced the next steps of the Public Hearing process.

City Manager Landers also offered comments regarding the Public Hearing process.

Read her letter she emailed on June 1, 2021 on behalf of her clients, a group of mobile homeowners at Rancho Dominguez Mobile Estate Mobile Home Park, to appeal Resolution No. 21-2708, with any amendments, approved by the Planning Commission on April 27, 2021 regarding the Relocation Impact Report (RIR) No. 04-19 in relation to the closing of the Rancho

Dominguez Mobile Estates Mobile Home Park and reasons for the appeal.

Mayor Pro Tem/Agency Vice Chairman/Authority Vice Chairman Dear would like to have an opportunity to ask Ana Zuniga questions.

Mayor/Agency Chairman/Authority Chairman Davis-Holmes stated questions can be done after close of the Public Hearing.

<u>Dehsong Matheu, Attorney at Neighborhood Legal Services</u> Spoke about the new law AB 2782 and the city's current relocation plan

Mayor/Agency Chairman/Authority Chairman Davis-Holmes stated she will allow five minutes for rebuttal from the applicant.

#### Thomas Casparian

Stated he preferred to respond to any questions that the City Council may have. He submitted a letter to the City Council today that included the documents that he referred to in his presentation today and includes all of the letters that notified prospective residents of the pending park closure, the expiration of the variance. Also, the documents that were given to each one of the homeowners when they moved in that includes their initials on each one of the documents. As he set forth in his presentation before, he met with the city in all sorts of capacities with lawyers, without lawyers, the old Planning Director, the current Planning Director and have been trying to do something about this for years. He reiterated the point that the documentation is extensive.

Mayor/Agency Chairman/Authority Chairman Davis-Holmes closed the Public Hearing at 9:22 P.M.

City/Agency/Authority Attorney Soltani presented key points and for Spanish Interpreter Diana to relay message. She noted process for residents to follow to redo their appraisal. She also noted the Planning Commission had resolution if residents have done upgrades that have not been properly appraised can be re-evaluated. She offered Executive Assistant Sylvia Rubio to take messages from Spanish speaking residents for assistance.

Interpreter Diana interpreted a resident's question: At the last meeting, the City Attorney Benjamin Jones stated that it was based on the closure of the park. They used the same prices of the homes and it was not updated. Why do we have to stay with them?

City/Agency/Authority Attorney Soltani asked Interpreter Diana to explain to the residents that this is not a question/answer period and that she is providing information and responding to the arguments presented. She would be happy to have people call in later and happy to answer any questions after the Public Hearing since it is closed. Providing responses to the issues raised and to provide information for the residents at this time.

Mayor/Agency Chairman/Authority Chairman Davis-Holmes requested staff to write additional questions and can address later in the meeting. She also requested Executive Assistant Sylvia Rubio's contact number.

Director Naaseh provided contact number (310) 952-1761 for Executive Assistant Sylvia Rubio and if she is not available to ask for an employee who also speaks Spanish such as Alvie Betancourt or Maria Gonzalez.

City/Agency/Authority Attorney Soltani noted another issue the residents raised if the renters are going to receive any benefits; renters are not going to receive any fair market value of coaches because they do not own their own coaches. However, the Planning Commission has included them in the relocation benefits that they would receive and the Planning Commission included them in the one year rent subsidies that they would receive. Renters receive some benefit as well and if the City Council were to take any of their measures to further mitigate the impacts of the park closure on the residents, the City Council can include those benefits for the renters as well.

Interpreter Diana confirmed she is interpreting City Attorney Soltani's comments verbatim.

City/Agency/Authority Attorney Soltani addressed Thomas Casparian's issues raised as follows:

- Bottom line is the City of Carson is not creating the park closure. The park closure is not the result of the city's planning, zoning actions or decisions; city has not started an enforcement action; there has not been any letters written to the park owner saying that the use has to stop right away. In fact, there were many letters exchanged with Mr. Casparian. They are all in the record for the City Council. There is a case law we cited in those letters that hold that amortization periods as applied to parks that will remain ongoing until a city compels the owner to close a park. The case law has held that it means that they get an extended amortization period. The 35-year period specified in the city's ordinance at that time is merely a safe harbor period during which the City Council would not pursue any actions to eliminate the non-conforming use of the park. After that any years that the park owner gets that's additional years. The City has not started a park closure or required this. In fact, in the correspondence as the residents pointed out the city did offer for the park owner to apply for a change of use if they wanted to if they did not want to close the park. They never pursued that and ignored that offer. She wanted the record to be clear this is a park owner-initiated park closure. There are plenty of correspondences on this issue.
- Issue raised by the residents about the Brabant appraisal. There are two issues under State law that the City Council has authority to consider. Under Assembly Bill (AB) 2782, residents are correct. The city has to require a fair market value in place appraisal of the coaches. What a willing knowing buyer is willing to pay to a willing knowing seller as if the park is going to continue and the park closure is not occurring. That is the issue some of the residents and the attorney representing Ana Zuniga are missing. This park presents a unique and unusual circumstance. AB 2782 does, in fact, clarify that is an in place value which Mr. Brabant has appraised and in his response letter which is Exhibit 10 to the staff report, he clarifies that under appraisal assumption they have to assume that the zoning laws are the zoning laws. Since the park is in a non-conforming use and willing knowing buyers have been paying a certain amount of money for it that is the fair market value analysis. Mr. Brabant explained in his letter between January 2009 and April 2020 there were a total of 32 sales in the park, 11 of those were purchased by residents so it was a purchase between residents and 21 by the park owner. Overall, he said there was a broad range in the 32 sales ranging from \$1,500 to one outlier at \$63,000 in 2009. He excluded

the outlier. The average of the sale was \$22,972. The 22 one park purchase ranged from 5,000 to 30,000 with an average of \$18,505. The resident purchases. The average of the other 10 sales was \$18,950 which was very close to the range of what the park owner had paid. His data he concludes supported that a willing knowing buyer was willing to pay in the neighborhood of \$18,505. Mr. Brabant's appraisal appraises the units on the average of \$28,000. It is higher than the sales that took place during that time period. He had his reasons for making the upward adjustments for the fair market values. The appraisal is AB 2782 compliant but thinks the residents are correct that the city absolutely has discretion under the new language in Government Code Section 65863.7 to impose any other conditions that the City Council fines are necessary to mitigate the negative impacts of the park closure. Specifically, subsection (k) of Government Code Section 65863.7 states, "This section establishes a minimum standard for local regulation of the conversion of a mobilehome park to another use, the closure of a mobilehome park, and cessation of use of the land as a mobilehome park and shall not prevent a local agency from enacting more stringent measures." The City Council definitely has further discretion to impose any conditions that the City Council believes are needed to adequately mitigate the impacts upon the ability of the displaced residents of the mobilehome park to find adequate housing in another mobilehome park. If the City Council finds an average of \$28,000 per coach is not sufficient and the one-year subsidy given by the Planning Commission's not sufficient, the City Council is free to look at other benefits to provide for the residents. Although the residents are correct in their concerns they are expressing about whether the fair market value will allow them to find adequate housing. The method used on the appraisal is not incorrect. It was a correct method but the City Council does have discretion during deliberations come up with other benefits if the City Council deems that to be the appropriate approach. The issue going back to Thomas Casparian's allegations that somehow they tried to seek a continuance or they wanted to get another variance at the time. I do not think any formal action was taken; it was dialogue between staff and attorneys but even if there was formal action by the city at that point if the park owner was unhappy with the city's decision, the park owner could have sued the city at that time or could have brought an action to try to address their claims at that time. A decade later they try to file a park closure application and say it is the city's fault. The city never commenced the park closure and never ordered the park to close.

City/Agency/Authority Attorney Soltani stated issue raised by Brabant appraisal. Two issues under state law; addressed AB 2782 and Government Code Section 65863.7; spoke about adequate housing. The City Council had discretion to come up with other benefits.

City/Agency/Authority Attorney Soltani stated issue by Thomas Casparian allegations regarding another variance; city never commenced park closure. She asked if Assistant City Attorney Benjamin Jones has anything to address that she may have missed. Assistant City Attorney Benjamin Jones stated that City Attorney Soltani covered everything and thanked her.

Director Naaseh noted the direct phone number for Executive Assistant Sylvia Rubio is (310) 952-1700, extension 1318 for assistance in Spanish.

Council Member/Agency Member/Authority Board Member Hilton asked for a dedicated line for the residents' questions to be answered; inquired if provided to residents in Spanish; 30-year mark; were these coach owners who rented their homes to people and told them that they would be there for 30 years or was it the park owner who is asking the questions.

Mayor/Agency Chairman/Authority Chairman Davis-Holmes inquired if the park manager who provided the information.

City/Agency/Authority Attorney Soltani stated Thomas Casparian tried to address the issue and he said it may have been the park owner trying to get an extension from the city. She reviewed the record and Thomas Casparian was correct that there has been notice given to the residents at the time they were buying their coaches in writing. If the residents were verbally presented to them that there is going to be an extension and residents relied on it. If you look at the purchase since the residents paid for their coaches compared to some of the other mobilehome parks in the city, the purchase price they paid is reflective because they were lower purchase prices they paid. It is reflective of the fact that they must have been on notice that the park is going to close. That is the point the City Council should focus on. If the residents had paid \$150,000 for their coach because the park owner was misrepresenting to them that the park was going to remain open, that would be a fraudulent activity. The purchase price would have been so outrageous that the City Council should look at how to address it. But if you look at the record, even if the park owner was verbally misrepresenting that the park is going to remain open, the purchase price that the residents were paying as shown in the appraisal was reflective of the fact that the park was probably going to close.

Council Member/Agency Member/Authority Board Member Hilton stated to differentiate that one person said that Mr. Brabant did their appraisal and received another appraisal from an outside appraiser. He inquired what makes Brabant valid and relevant and his numbers being from the estimation that they said were between \$150,000 so his estimation being almost \$123,000 off. He asked the City Attorney to explain because people were saying that their house is worth more than \$28,000 and do not want the City Council to go down the path to say that they are not concerned about the citizens when they are.

City/Agency/Authority Attorney Soltani stated that it is another point to address. Brabant appraiser indicated that the zoning compliance was legal but it is not which we know. The appraiser's assumption was inaccurate. Also, instead of looking at all the sales that took place within the park, there is plenty of sales that took place within the park he ignored all of that and he relied on four comparable sales. Out of the ten appraisals that he conducted and all of those four comparable came from Colony Cove and Carson Harbor Village which are the two top notch parks in the City of Carson. The appraisal was not done properly. Mr. Brabant has relied on comparable sales and sales that have taken place within the park. The residents are raising the fact that the park owner has been buying the coaches but as presented Mr. Brabant's rebuttal, he had ten sales that were between residents where the park owner is not involved and those sales all were within the same range as to what the park owner paid. If you exclude the park owner's sales and you only look at the sales that happen resident to resident, a willing knowing buyer paid \$18,000 on the average for the coaches to a willing knowing seller. You cannot ignore under appraisal laws or rules. You cannot ignore the zoning, the legal non-conforming status of the park. The appraiser who has done the appraisals on behalf of the residents is just basically saying that the zoning is legal and compliant because if he had looked at the true zoning he would have had a different result.

Council Member/Agency Member/Authority Bod Member Hilton stated the attorney Ana Zuniga referred to AB 2782 just passed and how they were not in line with that. He asked if City Attorney Soltani can speak to that if closure is in line with that or not.

City/Agency/Authority Attorney Soltani stated very complex issues dealing with. Yes, AB 2782 requires mobilehome park appraisals to be based on the current in place value of the mobilehome and shall assume that the park closure is not happening. The legislative history of AB 2782 is that the legislature wanted to avoid off site value. They wanted to clarify that a park and appraiser cannot say the park closure application is pending therefore because the park closure application is pending now all the prices are lower so I'm going to appraise the coaches at low values. That was the purpose of AB 2782. In this situation, Mr. Brabant is not looking at the park closure to say that the values are impacted. He is looking at the zoning not being legal conforming and under appraisal rules, an appraiser is required to look at zoning. You cannot ignore zoning and if there is a legal non-conforming zoning you cannot just disregard that. I understand it creates confusion in this situation because this is a very unique circumstance. It is an exceptional circumstance we are dealing with because you have a park where coach values for decades have been impacted because of the legal non-conforming use of the park and in valuing that the appraiser has taken into consideration that impact. But because there is a pending park closure application, it can get confusing and somebody can think well this is because of the park closure application. It is not because even if the park closure application was not happening without the park closure application, what these coaches are selling on the open market is what the appraiser relied on. It is the \$18,000 exchanges that are happening but vet your appraiser Mr. Brabant evaluation is at average of \$28,000 per coach so it is even higher than what has been happening on the open market.

Mayor/Agency Chairman/Authority Chairman Davis-Holmes referred to page 111 of the report which has each coach and value, off site and on site.

City/Agency/Authority Attorney Soltani stated the Planning Commission also imposed a condition. There are a couple of outliers that for some reason those residents paid substantially more than what other residents have been paying for those coaches. One was at \$63,000. Even those residents are going to be made whole because the Planning Commission condition said if a resident paid more for their coach than the appraised value, then the resident shall get the purchase price. The Planning Commission tried to address the residents who may have paid more for their coaches than the fair market value.

Council Member/Agency Member/Authority Board Member Hicks stated some residents owe \$40,000 or \$50,000 on their coach so if doing \$28,000 his concern is what will happen with the balance that is owed on the coaches if they are only valued at \$28,000 but in the same breath they are going to be made whole based upon the purchase price. City/Agency/Authority Attorney Soltani responded in the affirmative.

Council Member/Agency Member/Authority Board Member Hicks stated but in the event he bought his coach at \$23,000 and received a loan because it was valued more than that when I received a loan offer. What is going to happen to the loan if I have other obligations on the property?

City/Agency/Authority Attorney Soltani stated if the residents have a loan that is higher than their purchase price and the fair market value, they should bring that to the city and contact Spanish speaking staff and if English speaking they can contact Director Naaseh and can look at the individual circumstances and see if there is a remedy that can be thought of and presented to the park owner and a solution from the city for the residents. The City Council has discretion to make sure to mitigate the adverse impacts of the park closure. If there is a loan that was taken out that would hinder the resident from receiving the fair market value of their coach to be able to find other housing when they get displaced, there has to be something that the city can do about that. The City Council can consider imposing additional conditions/benefits to try to mitigate the impacts further on the residents.

Council Member/Agency Member/Authority Board Member Hicks noted concern that it was stated by Thomas Casparian in his testimony regarding the notification to the individuals living in the mobilehome park; you had people who moved in 2009 and in 2012. Clearly, they were informed of any closure to some degree because something was told to them separate and was told about a \$30,000 extension that was given and feels there has not been clear information given to the residents and individuals were trying to at least circumvent the process by extending the rental agreement so they can continue to receive funds. If going to abide by the new law that became effective January 1, 2021 that we need to put a really good package together to support the residents and ensure they are made whole.

Mayor/Agency Chairman/Authority Chairman Davis-Holmes stated to look at the medium; coaches need to be addressed individually; concur with Council Member Hicks with a resident who has a loan on their home and bought at a higher price; likes Assistant City Attorney Benjamin Jones' tiered approach but seemed to lump everyone together and gave the same.

City/Agency/Authority Attorney Soltani stated the appraisal looked at each coach separately; each coach has a separate fair market value.

City/Agency/Authority Attorney Soltani stated the City Council can consider imposing a condition of approval that any resident who has a unique situation of having a mortgage or loan that exceeds the fair market value or the purchase price of their coach can submit that evidence to the city. Also, can ask the City Council to allow us to think of a fair approach to deal with that and try to reach an understanding with the park owner. If cannot do that for the limited purpose of only those individuals if can reach an understanding with the park owner will bring those limited units back to the City Council. Do not want to make a decision about those few individuals on the spot right now; the situations should have been presented to the staff earlier and residents have addressed this evening and the City Council's desire to help the individuals but need to understand the facts and circumstances better to come up with a fair approach to addressing the situation.

Mayor/Agency Chairman/Authority Chairman Davis-Holmes stated do not piece mail; approach all in one.

Mayor Pro Tem/Agency Vice Chairman/Authority Vice Chairman Dear stated the information appears contradictory; Thomas Casparian not presenting accurately and correctly. He asked City/Agency/Authority Attorney Soltani to explain AB 2782; not in favor of park closing and is being done because of an economic decision for themselves; even if the park goes through the

process of closure, it will not be closed for at least two years from now and with the COVID-19 pandemic still in existence, residents need an opportunity to relocate. He asked City/Agency/Authority Attorney Soltani to outline AB 2782 and how it would affect the park; agree to not have a cookie cutter approach of one size fits all.

City/Agency/Authority Attorney Soltani stated the Planning Commission imposed a one year timeline and the City Council can increase timeline to two years to mitigate the negative impacts of the park closure in the midst of COVID-19 on the residents which would be a fair additional condition if the City Council would like to impose that; outlined AB 2782 which is the subdivision she read into the record earlier with greater discretion to address the issue; timeline; negative impacts; can impose condition; discretion of AB 2782; mitigation.

She stated that she and Assistant City Attorney Benjamin Jones are deliberating what could be an approach that addresses the request to not have a cookie cutter approach. The Planning Commission gave each resident an additional one year of rent subsidies. She explained the rent subsidies; perhaps a tiered approach to providing rent subsidies to mitigate impact of the park closure. She and staff can come back with an approach.

Mayor Pro Tem/Agency Vice Chairman/Authority Vice Chairman Dear stated he likes the tiered approach; case by case.

Mayor/Agency Chairman/Authority Chairman Davis-Holmes stated to address individual needs.

Mayor Pro Tem/Agency Vice Chairman/Authority Vice Chairman Dear recommended to bring item back in two weeks and requested to make sure not to put residents on the street and make sure they are able to live for two or three years if park closes that they have rent subsidies they need to survive; do not like rushing to make decisions affecting 81 units. The City Council needs to come up with the best package and requested to discuss with each resident to explain.

City/Agency/Authority Attorney Soltani stated if the City Council is inclined to continue the meeting, she can work with staff and talk to experts in the field to find out what would be sufficient rent subsidies to make sure that we sufficiently mitigate the impacts. Meanwhile Interpreter Diane can inform the Spanish speaking residents anyone who has the mortgage situation will need to have the information as soon as possible to allow time to prepare proposal for the City Council at the next meeting.

Mayor/Agency Chairman/Authority Chairman Davis-Holmes requested staff to come back with actual recommendations.

Mayor Pro Tem/Agency Vice Chairman/Authority Vice Chairman Dear suggested to hold a special City Council meeting.

Council Member/Agency Member/Authority Board Member Hicks recommended staff come up with an Option C.

Mayor/Agency Chairman/Authority Chairman Davis-Holmes requested an extension for City Council. She asked Director Naaseh if on a time constraint.

Director Naaseh requested to continue the item to a date certain.

Mayor/Agency Chairman/Authority Chairman Davis-Holmes suggested the special meeting be held outside of regular meeting before June 15, 2021.

Mayor/Agency Chairman/Authority Chairman Davis-Holmes stated she is good for Wednesday, June 16, 2021, at 5:00 P.M. with Council Members in consensus.

Council Member/Agency Member/Authority Bod Member Hilton stated subsidies to be in a lump sum.

City/Agency/Authority Attorney Soltani stated to continue the Public Hearing to June 16, 2021, at 5:00 P.M.

Mayor/Agency Chairman/Authority Chairman Davis-Holmes reopened the Public Hearing at 10:19 P.M.

Mayor/Agency Chairman/Authority Chairman Davis-Holmes requested that the Public Hearing be continued to Wednesday, June 16, 2021, at 5:00 P.M.

Director Naaseh asked if same set up from this evening for the Community Center or Zoom meeting and would share the link.

Mayor and City Council were in consensus of the same set up for the next meeting.

Mayor/Agency Chairman/Authority Chairman Davis-Holmes requested to allow other speakers to speak.

Mayor Pro Tem/Agency Vice Chairman/Authority Vice Chairman Dear requested staff to verify the speakers' comments regarding amounts.

Mayor Pro Tem/Agency Vice Chairman/Authority Vice Chairman Dear stated Mr. Brabant does not enter the house.

City/Agency/Authority Attorney Soltani stated that Mr. Brabant enters to appraise and tried to contact residents with no response. The park owner sent letters to the residents and they were non responsive to Mr. Brabant.

Assistant City/Agency/Authority Attorney Benjamin Jones stated half of the residents responded to the questionnaires; Mr. Brabant did not enter homes due to COVID and tried other means; it should be noted there is a condition of approval, however, that says if there is any error in the appraisal based on not taking into account some improvement or modification that was made to a mobile home, there is a process for residents to apply for a modified and adjusted appraisal using the same methodology but taking into account those factors and adjusting the appraised value accordingly. He discussed the Brabant appraisals.

Mayor Pro Tem/Agency Vice Chairman/Authority Vice Chairman Dear stated those factors should be taken into account and do not know why the park owner would not cooperate; some people spoke tonight who indicated that they made improvements in their home and that falls under the category Assistant City/Agency/Authority Attorney Benjamin Jones described and those individuals should be contacted by staff.

Mayor/Agency Chairman/Authority Chairman Davis-Holmes requested to extend the meeting past 11:30 P.M. with no objection heard.
