Mayor/Agency Chairman/Authority Chairman Davis-Holmes stated she attended the 90th Annual Conference of Mayors. There were cities doing less activities than the City of Carson with their Sheriff Department being recognized. She would like the Carson Sheriff Station recognized next year. She shared a 24-Hour Mass Shooting Protocol pamphlet with the City Manager and would like to have a round table discussion with all Mayors in the area with the Sheriff.

Captain Jones reported the Community Relations Office hosted an Active Shooter Response and Training with City staff last week.

Mayor Pro Tempore/Agency Vice Chairman/Authority Vice Chairman Hilton reported on the homelessness at the Walmart parking lot versus the Target parking lot. He requested Captain Jones to address homelessness in the City. Captain Jones responded to his request.
