Item No. 24 was heard after Item No. 19.

City Clerk/Agency Secretary/Authority Secretary, Dr. Bradshaw gave the Public Hearing report.

Director Naaseh gave a staff report.

Council Member/Agency Member/Authority Board Member Hicks inquired about the outreach to residents for this project.

Director Naaseh confirmed that residents within a 750-foot radius were contacted.

Council Member/Agency Member/Authority Board Member Dear expressed concerns about the location of the project site and how it could potentially impact nearby single-family homes.

At 7:34 P.M., Mayor/Agency Chairman/Authority Chairman Davis-Holmes declared the Public Hearing open.

David Blumenthal, representative for Sagecrest Planning and Environmental, discussed further details about the project and how local neighbors were both aware and in favor of the project.

Council Member/Agency Member/Authority Board Member Dear inquired about the inclusion of affordable housing units and it was confirmed by representative Blumenthal that affordable

housing would not be included in this project.

Nancy Kim expressed that her goal for this rental property is to be involved in the community and build longevity.

Council Member/Agency Member/Authority Board Member Dear inquired about why underground parking was not incorporated in the proposed project.

Art Ashai, architect for Nancy Kim, expressed that they did not consider underground parking for this project because it is an expensive process.

Council Member/Agency Member/Authority Board Member Dear expressed concerns of whether this project proposes any environmental issues since the site was once a gas station.

Mr. Reynolds confirmed that there are conditions that this project is subject to relative to secondary testing because of its former use as a gas station, including a report based on that testing.

Council Member/Agency Member/Authority Board Member Dear inquired about any gas extraction systems or barriers between the contaminants for this project.

Mr. Reynolds confirmed that a labor intrusion barrier is included if necessary and the required secondary testing also includes vapor intrusion as part of the conditions.

Council Member/Agency Member/Authority Board Member Dear inquired about any sensors to protect residents from harmful gases or hazardous materials.

Mr. Reynolds confirmed conditions for hazardous materials do not explicitly specify that because the result of the secondary test needs to dictate what additional steps may be required.

Mr. Reynolds confirmed that the total cost of this project has not been determined.

Council Member/Agency Member/Authority Board Member Dear asked Nancy Kim if she has personally met any of the neighbors and she confirmed that she did during COVID-19 and those neighbors were in favor of the project.

Nancy Kim confirmed that the management company she hired is professional and has a strong commitment to the community.

Mayor/Agency Chairman/Authority Chairman Davis-Holmes inquired about the removal of tanks and the probability of this project not coming to fruition due to the contaminated soil.

David Blumenthal stated the tanks have been removed and Phase 2 has been completed. The only mitigation measure that needs to be addressed is the vapor barrier underneath the building and protection measures for safety. However, this will not impact the development of the project site. It has been confirmed that there is no evidence of any underground tanks or piping left on the site.

Mayor/Agency Chairman/Authority Chairman Davis-Holmes questioned Nancy Kim about her proximity to the project site.

Nancy Kim confirmed that she resides approximately 15-20 minutes away from the project site, therefore she can be very hands on.

Mayor/Agency Chairman/Authority Chairman Davis-Holmes expressed concerns about the number of residents were notified about this project and the new State laws regarding building development.

Council Member/Agency Member/Authority Board Member Rojas inquired about charging spaces for electric cars.

Art Ashai confirmed there will be charging spaces for electric cars.

At 8:07 P.M. Mayor/Agency Chairman/Authority Chairman Davis-Holmes closed the Public Hearing.

Council Member/Agency Member/Authority Board Member Rojas asked if there was any outreach to the new Islamic church located near the project site.

David Blumenthal stated that notices were mailed to owners and occupants within 750 feet of the project site.

Mayor Pro Tempore/Agency Vice Chairman/Authority Vice Chairman Hilton expressed gratitude for efforts to remediate the vacant land.
