SECOND READING OF ORDINANCE NO. 23-2309 AMENDING VARIOUS SECTIONS OF CHAPTER 6 (PURCHASING SYSTEM) OF ARTICLE II (ADMINISTRATION) OF THE CARSON MUNICIPAL CODE

I. SUMMARY

OF THE CARSON MUNICIPAL CODE AS A COMPREHENSIVE UPDATE”
