RESOLUTION NO. 23-09-CHA, A RESOLUTION OF THE CARSON HOUSING AUTHORITY RATIFYING CLAIMS AND DEMANDS IN THE AMOUNT OF \$13,483.51, DEMAND CHECK NUMBERS HA-001952 THROUGH HA-001953
