RESOLUTION NO. 24-02-CSA, A RESOLUTION OF THE CARSON SUCCESSOR AGENCY RATIFYING CLAIMS AND DEMANDS IN THE AMOUNT OF \$11,091.25, DEMAND CHECK NUMBERS SA-001913 THROUGH SA-001915
