RESOLUTION NO. 24-01-CHA, A RESOLUTION OF THE CARSON HOUSING AUTHORITY RATIFYING CLAIMS AND DEMANDS IN THE AMOUNT OF \$6,554.17, DEMAND CHECK NUMBERS HA-001973 THROUGH HA-001974
