RESOLUTION NO. 23-023, A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CARSON RATIFYING CLAIMS AND DEMANDS, AS FOLLOWS:

TOTAL OF \$8,813,315.39 FOR GENERAL DEMANDS, CHECK NUMBERS 165564 THROUGH 165892.

TOTAL OF \$15,075.00 FOR CO-OP AGREEMENT DEMANDS, CHECK NUMBERS 1268 THROUGH 1268, WHICH ARE COSTS ASSOCIATED WITH THE CONSTRUCTION OF CAPITAL PROJECTS WITHIN THE FORMER REDEVELOPMENT PROJECT AREA, USING BOND PROCEEDS TRANSFERRED FROM THE SUCCESOR AGENCY TO THE CITY.

THE CITY COUNCIL OF THE CITY OF CARSON DOES HEREBY RESOLVE, DETERMINE AND ORDER AS FOLLOWS:

The City Treasurer is hereby directed to pay, out of the funds named hereon, to each of the claimants listed above, the amount of warrant appearing opposite their respective names, for the purpose stated on the respective demands, making a total of \$8,828,390.39.

<u>SECTION 3:</u> That the City Clerk shall certify to the passage and adoption of this Resolution and enter it into the book of original resolutions.
