RESOLUTION NO. 23-13-CHA, A RESOLUTION OF THE CARSON HOUSING AUTHORITY RATIFYING CLAIMS AND DEMANDS IN THE AMOUNT OF \$27,347.82, DEMAND CHECK NUMBERS HA-001968 THROUGH HA-001972
