RESOLUTION NO. 23-11-CSA, A RESOLUTION OF THE CARSON SUCCESSOR AGENCY RATIFYING CLAIMS AND DEMANDS IN THE AMOUNT OF \$22,002.40, DEMAND CHECK NUMBERS SA-001908 THROUGH SA-001909
