RESOLUTION NO. 23-08-CHA, A RESOLUTION OF THE CARSON HOUSING AUTHORITY RATIFYING CLAIMS AND DEMANDS IN THE AMOUNT OF \$27,224.19, DEMAND CHECK NUMBERS HA-001946 THROUGH HA-001951
