RESOLUTION NO. 24-04-CHA, A RESOLUTION OF THE CARSON HOUSING AUTHORITY RATIFYING CLAIMS AND DEMANDS IN THE AMOUNT OF \$21,243.67, DEMAND CHECK NUMBERS HA-001981 THROUGH HA-001985
