RESOLUTION NO. 19-07-CHA, A RESOLUTION OF THE CARSON HOUSING AUTHORITY RATIFYING CLAIMS AND DEMANDS IN THE AMOUNT OF \$42,898.04, DEMAND CHECK NUMBERS HA-001779 THROUGH HA-001782
