RESOLUTION NO. 24-06-CSA, A RESOLUTION OF THE CARSON SUCCESSOR AGENCY RATIFYING CLAIMS AND DEMANDS IN THE AMOUNT OF \$4,725.10, DEMAND CHECK NUMBERS SA-001925 THROUGH SA-001927
