RESOLUTION NO. 20-01-CHA, A RESOLUTION OF THE CARSON HOUSING AUTHORITY RATIFYING CLAIMS AND DEMANDS IN THE AMOUNT OF \$17,522.60, DEMAND CHECK NUMBERS HA-001789 THROUGH HA-001791
