TOTAL OF \$2,192,242.60 FOR GENERAL DEMANDS, CHECK NUMBERS 130655 THROUGH 130791.

TOTAL OF \$44,390.68 FOR CO-OP AGREEMENT DEMANDS, CHECK NUMBERS 1060 THROUGH 1062, WHICH ARE COSTS ASSOCIATED WITH THE CONSTRUCTION OF CAPITAL PROJECTS WITHIN THE FORMER REDEVELOPMENT PROJECT AREA, USING BOND PROCEEDS TRANSFERRED FROM THE SUCCESOR AGENCY TO THE CITY.
